Board Attorney Hanly said he will reach out to Harold Cook, the applicant's Attorney to discuss the matter.

### MEMORIALIZING RESOLUTION

Chairman Fortunato stated that the Board voted on the Resolution during the Work Session however, after discussions with Mr. DiGennaro and Mr. Hanly, it was decided that the Board cannot formally approve the Resolution. Mr. Hanly will reach out to the applicant's Attorney,

Harold Cook to discuss the matter of the side yard setback variance which should have been addressed during testimony. The parking should also be discussed, as Mr. DiGennaro states no parking variance is required. The Chairman said Mr. Cook can come back with one of his expert witnesses so the Board can address the side yard setback variance. Mr. Hanly will also have to request Mr. Cook's approval to carry memorializing the Resolution past the 45 day time period until the matter can be resolved.

Chairman Fortunato said that for the record, the Board should make a motion to rescind the approval of the Resolution which was voted on during the work session meeting. Mr. Boonstra said that under "Robert's Rules of Order", the Board can rescind or reconsider the approval of the Resolution in the reverse of how the motion was made and seconded.

Mayor Melchionne made a motion to rescind his vote to second the original motion to approve the Resolution. Ms. Caprio made a motion to rescind her previous motion to approve the Resolution. Voting in favor of rescinding the approval: Mr. Kaufman, Mr. Vander Plaat, Ms. Caprio, Mr. Boonstra, Mayor Melchionne, and Chairman Fortunato.
