Ms. Spreen-Raffo asked the BOH if the Board of Education was aware of the free programs/resources available from the BCDOH regarding the issue of vaping. Ms. Garbaccio stated that the Board of Education was aware of the available resources.

Ms. Brock attended a training session on how to better care for those in need presented by New Hope Community Ministries at the Cedar Hill Reformed Church on November 5, 2019. Ms. Brock handed out resources to BOH members; although many of the resources apply to Passaic County residents, some resources are available to residents of New Jersey.

Ms. Garbaccio stated that she is no longer able to attend the Stigma Free meetings at the Christian Healthcare Center (CHCC). Ms. Brock stated she would attempt to attend the Stigma Free meetings whenever feasible and represent the BOH.

Ms. Risseeuw informed the Board Members that the BCDOH will be having a kickoff meeting for the 2020 Wellness Challenge on Monday, November 18, 2019 at 1:00 pm at the Parsons Pond Building in Franklin Lakes. Ms. Risseeuw asked if any BOH members would be interested in taking on this responsibility; however, due to current work commitments, no BOH members are available during daytime hours.

#### Old Business

Walgreen's administered 52 flu vaccines to Township of Wyckoff Employees and First Responders on Monday, October 21, 2019 at Company #1 Firehouse. Thank you to Lynne Spreen-Raffo, Devaleena Sen, Linda Brock and Cindy Risseeuw who volunteered at the flu clinic to assist at the event.

Members were reminded of the following Open Public Records Act (OPRA) Law requirements. Board members must include the following language on all memos to board members:

"The Board/Commission Secretary or Liaison shall be included in any email a Township Committee appointed Board/Commission member sends. All emails are subject to the Open Public Records Act and as such, may be requested by citizens. (This requirement is applicable to all members of the Wyckoff Planning Board, Zoning Board of Adjustment, Library Board of Trustees, Recreation and Parks Commission, Board of Health, Environmental Commission, Shade Tree Commission, Design Review Advisory Committee and any other ad-hock committee regardless if it is sent from your personal/business computer or personal/business data phone.) There should be no expectation that the content of emails exchanged with municipal officials and employees will remain private."

Mike Sparozic motioned to close the Public session; seconded, Linda Brock; all members present voting affirmatively.
