APPLICATIONS CARRIED

GALASSO ENTERPRISES, LLC BLK 203 LOT 3.04 (L-2) 825 Windham Court North. Amendment to Existing Site Plan. Applicant proposes to add 56 additional parking spaces to the site which currently has 50 parking spaces.

Bruce Whitaker, the applicant's Attorney, had previously requested that the application be carried to the December 11, 2019 meeting at which time he will provide the Board Members with a status update of the application. He added that his client is working on revising the plans which should be ready by late December therefore the application will most likely have to be carried to the January meeting. He added that he will submit a letter prior to the December meeting with an update and his client will renotice.

KAYAL, GARY 225 Van Houten Avenue BLK 258 LOT 13 (RA-25).

The applicant proposes to import approximately 774 cubic yards of soil to raise the level of the rear yard and to construct a 3'- 4' boulder retaining wall to contain the soil.

The applicant and his professionals will provide testimony during the Public meeting.

ORDINANCE UPDATE

Mayor Madigan stated on behalf of the Township Committee that he would like to thank the Board Members for their many suggestions and recommendations regarding the Ordinances that were presented for review at the October Planning Board meeting. Mr. Boonstra also thanked the Board for the recommendations. He stated that the Township Committee integrated the recommendations into Ordinances 1890, 1891, 1892 and 1894, which pertain to the overlay zones, and those Ordinances have been adopted. Ordinance 1893, which pertains to buffers, was reworked and adopted. Ordinance 1889, which pertains to the pedestrian circulation and safety, is currently being reworked and will be reintroduced once it is complete. In summary, five of the introduced Ordinances have been revised and adopted and the remaining Ordinance will be reintroduced to the Planning Board Members for review before it is adopted by the Committee.

There being no further business, a motion to adjourn the Work Session meeting was made, seconded and passed unanimously. The Work Session concluded at 7:40 p.m.
