Open Public Meeting Act Statement

Municipal Clerk Santimauro read the "Open Public Meeting Act" Statement: "This regular meeting of the Township Committee of the Township of Wyckoff is now in session. Mayor Rooney Statement

Mayor Rooney stated that we will continue with the Open Public Meeting comment period during this 8:00 pm Township Committee Business meeting, this is the opportunity in the meeting for the public to provide comments to the Township Committee on any item on or off the meeting agenda.

Mayor Rooney greeted everyone seated in the audience and said, good evening,

As a dog owner myself the incident last week resulting in the loss of Otto was tragic. On behalf of my colleagues and myself, we extend to the family of Otto our sympathy.

The Township Committee continues to believe in the process and the ability of our Police Department to conduct the ongoing investigation. However, as a result of the unfounded accusations of a biased investigation, both Chief Fox and I wrote to Chief Martino, of the Bergen County Prosecutor's office, requesting that one of their detectives assist our Police Department in the ongoing investigation. In addition, I also requested Senator Kevin O'Toole to contact the Prosecutor's and Attorney General's offices.

While we appreciate your comments, please understand we will not engage you, as this is an ongoing police investigation and personnel matter.

Some ground rules, please turn off your cell phones or place them on silence. Speakers must begin by stating their name, address and organization if any. Speakers must be courteous in their language and comments and direct their comments to the Township Committee. There will be no debate or discussion between speakers and members of the audience.

If the rules are ignored, the public comment period will be closed.

You will have the ability to approach the microphone for public comment during our work session and business meetings.

Flag Salute

The Township Committee proceeded with the Pledge of Allegiance led by Mayor Kevin Rooney.

Invocation

The Invocation was given by Reverend Jeff Riley from Powerhouse Church.

Mayor Rooney Statement

Mayor Rooney explained to the audience that he too is a dog owner. Both he and his wife and family love dogs. Mayor Rooney has rescue dogs, he fosters dogs and occasionally takes dogs to his home from the dog shelter to be bathed. The Mayor reiterated that he has requested Senator Kevin O'Toole to contact the Prosecutor's and Attorney General's offices to help with the ongoing investigation.

Meeting Open for Public Comment

The Township Committee voted unanimously to open the public portion of the meeting.

Chris Scalia, 2249 Oakham Court, Mahwah, NJ. Mr. Scalia stated he is Igor Vukobratovic's best friend. Mr. Scalia indicated that the family is devastated, this shooting has shaken our trust in the police department. He was with Igor when Otto their dog was first brought home, Mr. Scalia said he and Igor have found three (3) ballistics in the yard, and they don't know why the police officers could not locate these ballistics. They have received letters in support from all over the country and from England. Police need to return and perform a thorough investigation and not hide behind it.

Nancy Allway, 36 Yawpo Avenue, Oakland, NJ. Ms Allway described herself as an animal lover and she considers her dog her son. She said Wyckoff is totally incompetent, you have a trigger happy incompetent cop and he is clearly incompetent. The officer should pay for the cremation bill.

Susan Winton, 80 Logan Lane, Wyckoff, NJ. Mrs. Winton described herself as a dog lover who has resided in Wyckoff for 50 years. She is heartbroken about the degradation of our police department and it is a disgrace for people who live outside of Wyckoff to make these comments. Our police officers do a good job and this situation is unfortunate. Mrs. Winton said she hoped this isn't a problem with the dispatch operation in Mahwah conducted by Bergen County.

Sheri Lengyl, 89 Crescent Avenue, Wyckoff, NJ. Ms. Lengyl described herself as a dog lover and indicated when this happened it was done to the extreme, we never heard anything from the cop that shot Otto, Police Chief Ben Fox took over. She said, Chief Fox is not civilized, he immediately came to the officer's defense without saying he will look into it, and he jumps to conclusion and offends the public. This is not "Foxdom" it is Wyckoff. Mrs. Lengyl said she works at the court house and they teach employees to be fair and respectful to the public. They have patches at the court house and Fair Lawn's police patch reads to help and protect, Wyckoff is an embarrassment, Police Chief Fox is not well liked, and she didn't think he cares. She is happy the police department will look into it. She hopes the rumors she has heard are not true. Thank you for taking the effort and action you say you will.

Rachael Speena , 135 Franklin Avenue, Oakland, NJ. Ms. Speena described herself as a lifelong dog owner, she works with dogs and she has received two (2) full days of training in order for her to work at her job with dogs. She has broken up fights between dogs, she has separated dogs that are fighting and if she can have this training why can't the police department have this training.

Sheri Lengyl, 89 Crescent Avenue, Wyckoff, NJ Ms. Lengyl stated mailmen get attacked by dogs all the time and they use spray. That is an option for the police rather than shooting dogs.

Mayor Rooney asked if anyone else in the audience had a public comment to make.

Mayor Rooney stated that he has asked Chief Fox to make some comments. Mayor Rooney stated that there have been multiple threats printed on line against Chief Fox, his family, the officer and his wife. This type of conduct is not acceptable in a civil society.

Mayor Rooney again extended his sympathies to the Vukobratovic family and stated that that on the evening of the 29th, the Chief called the Vukobratovic family and both of us requested to visit the Vukobratovic family to provide an explanation, they were too distraught to speak to us, but they spoke to the press that evening.

Police Chief Fox indicated that he has spoken to Mr. & Mrs. Vukobratovic when the incident occurred and he spoke to them and their son Igor tonight. He is also upset at what has occurred as much as everybody else. This is a sad and unfortunate occurrence, I said from the beginning that the officer responded to the wrong house, this is an ongoing investigation, no conclusions have been reached. We are very sad that we arrived at the wrong house. I read in the Bergen Record editorial that I said, but I don't recall saying, that this is a series of small errors. These were not small errors these were significant errors. Policing is not always perfect all the time, if something went wrong in fairness to the Vukobratovic family and the officer I want to correct it. I have requested complete oversight from the Bergen County Prosecutor's office, I haven't been assured that will happen. The Mayor wrote to Senator O'Toole and he contacted the New Jersey Attorney General, we want the investigation to be conducted with their assistance. I am sorry and devastated for the family. I feel horrible that they lost their family dog. A speaker this evening said we have to take a negative and turn it into a positive, I think that was correct, I can't undo some of the things, but we can learn from them and move ahead in a positive way. I have spoken to the Bergen County Communication Center and they have changed their protocol and that protocol is that after the officer calls in at a location, the dispatcher will repeat multiple times the location going forward to ensure it's the
