**ORDINANCE # 91**

**AN ORDINANCE TO AMEND CHAPTER 194 OF THE CODE OF THE TOWNSHIP OF WYCKOFF "FEES FOR BIRTH, DEATH AND MARRIAGE CERTIFICATES" TO AMEND SECTION 194-1 "FEES", TO INCREASE FEES AND PROVIDE FOR NEW FEES IN CONNECTION WITH VITAL STATISTICS.**

**ORDINANCE #91**

**AN ORDINANCE TO AMEND CHAPTER 194 OF THE CODE OF THE TOWNSHIP OF WYCKOFF “FEES FOR BIRTH, DEATH AND MARRIAGE CERTIFICATES” TO AMEND SECTION 194-1 “FEES”, TO INCREASE FEES AND PROVIDE FOR NEW FEES IN CONNECTION WITH VITAL STATISTICS.**

**BE IT ORDAINED**, by the Board of Health of the Township of Wyckoff, County of Bergen, State of New Jersey, that Section 194-1, Fees for birth, death and marriage certificates, is amended as follows:

**SECTION 1 Chapter 194, Fees;**

**Section 194-1. Fees for birth, death and marriage certificates.**

The fees to be charged for certified copies of birth, death and marriage certificates and other permits issued by the Registrar of Vital Statistics shall be as follows:

- A. Issuance of each burial permit: fee set by the state.
- B. Issuance of each marriage license: fee set by the state.
- C. Issuance of each certified copy of a birth certificate or death certificate: twenty five dollars (\$25.00) for the first certified copy; two dollars (\$2.00) for each additional certified copy thereafter.
- D. Issuance of a certified copy of a marriage certificate: twenty five dollars (\$25.00) for the first copy; twenty dollars (\$20.00) for each additional certified copy thereafter.
- E. For every change and/or correction to a birth, death or marriage certificate: ~~twenty dollars (\$20.00)~~ twenty five dollars (\$25.00).

**SECTION 2** - All others terms and provisions of Chapter 194 shall remain in full force and effect except as specifically modified herein.

**SECTION 3** - This Ordinance and the fees established herein shall take effect immediately upon final passage and publication as required by law.
