#14-227 <u>Culvert Restoration Project</u>

WHEREAS, New Jersey Department of Transportation (NJDOT) contacted the Township of Wyckoff to inform the Township Committee that a deficient structural and hydraulic culvert under Route 208 requires replacement via the removal of the corrugated metal pipe with a new precast concrete structure; and,

WHEREAS, this project will be funded by federal and state money; and,

WHEREAS, the Township Engineer attended the April 24, 2014 public information presentation conducted in Wyckoff Town Hall and hosted by NJDOT and recommends the project as a positive improvement which should help mitigate local flooding in the immediate area while providing safe passage along Route 208 for many years to come; and,

WHEREAS, as part of the conditions for a culvert replacement project, the Township must pass a resolution supporting the project; and,

WHEREAS, the NJDOT and Wyckoff Police Department will develop a traffic control plan using lane shifting that best meets the needs of the Township.
