- 2. The resolution awarding a contract for bi-annual shade tree work results in the lowest of three (3) bidders. As way of reminder, the Township does not pursue this procurement in the easy manner of time and material pricing. The Township has specific locations which have been requested by residents for tree work on the unpaved municipal right-of-way and individual prices are obtained. This is a rather lengthy process to assemble and bid however, it allows the municipality to "stretch" their limited dollars.
- 3. A proclamation has been prepared to thank former Township Committeeman Brian D. Scanlan for his service on the Township Committee and serving as Mayor to the Township of Wyckoff.
- 4. Two (2) salary ordinances are listed on this evening's agenda. Since the PBA and Wyckoff Road Association contracts currently exist, it is the practice of the Township to adopt these ordinances in the current year for the upcoming year salaries so that the first pay of the new year will reflect the employee's new salary. A public hearing and further consideration will be conducted on Tuesday, December 17, 2019.
- 5. The Township Committee, as mentioned by Mayor Madigan, at the conclusion of the 8:00 p.m. Consent Agenda and before adjournment, will conduct interviews of two (2) of the three (3) nominees for the Township Committee vacancy created by the resignation of Township Committeeman Brian D. Scanlan. Those conversations remain in open session and the public may attend. However, for reasons of equal treatment, continuity, the ability to conduct a productive, informal and straightforward discussion, the interviews will be conducted in the same setting for all three (3) nominees.

Timothy Shanley:

- 1. On Monday, December 2, 2019 Mr. Shanley attended the quarterly departmental meeting of the Wyckoff Volunteer Fire Department. At this meeting, the Christian Health Care Center was present and presented the fire department with a \$5,000 donation check honoring the first responders.
- 2. The Wyckoff Volunteer Fire Department reminds everyone that their primary fundraiser, "A Taste of Wyckoff" is scheduled for Friday, January 31, 2020 at the Wyckoff Family YMCA.
- 3. The Zoning Board met in November where routine business was conducted.

Melissa Rubenstein:

- 1. Ms. Rubenstein congratulated the Environmental Commission for achieving the Sustainability Silver Award.
- On Monday, December 16, 2019 the Environmental Commission Meeting will be conducted at the Wyckoff Free Public Library. At that meeting, Student Environmental Commissioner Members will present their projects.

Rudy Boonstra:

- 1. On Monday, December 2, 2019 the DPW began salting municipal roads at 7:00 a.m. Late bursts of snow at 10:00 p.m. resulted in six (6) inches of accumulated snow. The DPW crews finally completed the salting plowing and re-salting at 4:30 a.m. Mr. Boonstra thanked the DPW crews for their diligence and skillful manner.
- 2. Last week, Mr. Boonstra, Committeeman Shanley and Committeewoman Rubenstein attended the Interfaith Service at Advent Lutheran Church.

Mayor Madigan:

- 1. Mayor Madigan thanked all the members of the Clergy Association for the Interfaith Service last weekend.
- 2. This evening's Open Work Session has been a special evening where the governing body has presented proclamations to two (2) of Wyckoff's Finest as well as proclamations to the Junior Football Team and the Pee Wee Football Team who have achieved the "Super Bowl" Championships. The Township Committee will also present proclamations to the Ramapo Girls Varsity Soccer Team, the Bergen County Champions and the New Jersey Sectional Champions at the 8:00 p.m. meeting.

3. Mayor Madigan advised all that the police electronic message sign posted outside of Town Hall reminds everyone that on Friday, December 6, 2019 at 7:15 p.m. the Wyckoff Chamber of Commerce will sponsor "Santa Comes to Wyckoff" and Tree Lighting Ceremony." The Wyckoff Volunteer Fire Department will be escorting Santa this evening.

Policy Action Items:

- 1. The fourth quarter Safety Report is presented to the governing body for review and consideration. Safety is a positive fiscal operation and the Township's achievements are listed in that report.
- 2. In November, the DPW was able to pave two (2) shorts roads, Coudert Place and Durham Road. The Summer Paving Project came slightly under budget due to competitive bid prices, therefore, at the discretion of the contractor's schedule, without charging the Township re-mobilization charges, these roads were milled and paved.
- 3. The Wyckoff Police Department, along with the New Jersey DMV, conducted a vehicle inspection last week. The statistics remain alarming. For two (2) consecutive years, the pattern is clear that many vehicles are driving through Wyckoff roads that are not safe. As way of example, in this three (3) hour checkpoint, twenty-three (23) vehicles were stopped and thirty-one (31) summonses were issued. Twenty (20) summonses were issued for vehicles which do not have safety inspections. Five (5) vehicles received summonses for failure to repair inoperable brake or headlights. Three (3) summonses were issued for operating an unregistered vehicle.
- 4. A notice was received from the court that the Township's Shared Service Court Administrator requested to use \$900 of DWI Surcharge Funds for a Special Court Session. The request was approved.
- 5. In last week's packet, two (2) responses from the Administrator to two (2) requests received through the Township's website to utilize the Township's webpage in a manner that would have constitutes a public forum. These consistent denial replies are designed to prevent litigation.
- 6. The Administrator was pleased to report that the Township Committee received a notice from the New Jersey Department of Transportation (NJDOT) that the Township has been awarded \$195,000 grant to repair the Mountain Avenue culvert. The Capital Budget will include engineering design and inspection costs effective January 1, 2020. The maximum engineering cost estimate exceeds the grant so additional funds will be appropriated in the 2020 Budget.
- 7. The New Jersey League of Municipalities Magazine included an article authored by Dave Grubb, the Executive Director of the Joint Insurance Fund (JIF) regarding the recent law that allows individuals who have suffered child abuse to sue up to age fifty-five (55). Due to this law, the JIF is implementing measures that will protect the taxpayers and will require training and supervisory training for all volunteer coaches in the recreation program as well as board and commission volunteers.
- 8. Nine (9) requests were received from residents wishing to know when the third round of leaf collection will be performed via the website. A third round of leaf collection has begun in District 1.

- 9. The 2020 Municipal Resident Calendar was delivered to the post office in anticipation of delivery to residents this week. The calendar is chockfull of both informative, useful, timely and critical municipal information. This year, the calendar theme reflects the technology utilized by the municipality and entitled "2020 Vision."
- 10. The Municipal Clerk issued a filming permit today for a commercial being filmed by BMW on Midland Avenue. This permit has earned the Township \$1,900 of non-tax revenue. Earlier in the year, a number of complaints were received from residents on Laurel Lane resulting in a policy change to require the filming company to pay for off-duty police officers to oversee any problems when filming occurs.
- 11. Two (2) community events are scheduled for this week. On Friday, December 6, 2019 Santa Comes to Wyckoff and Tree Lighting Ceremony at 7:15 p.m. in Town Hall. Then, on Sunday, December 22, 2019 the Menorah Lighting Ceremony will be conducted. This year, the Township will be installing on the front lawn of Town Hall the Holiday Display which included both secular and religious items. The focal point of the display is the sign which reads, "During the Holiday Season, the Township of Wyckoff salutes Liberty. Let this festive display and times remind us that we are the keepers of the Flame of Liberty and our Legacy of Freedom. Whatever your beliefs, enjoy the Holidays."
