Mayor Thomas J. Madigan opened the Open Work Session Meeting at 7:00 p.m. in the second floor municipal court room.

Township Administrator/Deputy Clerk Shannon read the Open Public Work Session statement: "This Open Public Work Session Meeting of the Wyckoff Township Committee is now in session. In accordance with the Open Public Meetings Act, notice of this meeting appears on our Annual Schedule of meetings. A copy of said Annual Schedule has been posted on the Bulletin Board in Memorial Town Hall; a copy has been filed with the Municipal Clerk, The Record, The Ridgewood News and the North Jersey Herald and News – all newspapers having general circulation throughout the Township of Wyckoff. At least 48 hours prior to this meeting the Agenda thereof was similarly posted, filed and mailed to said newspapers."

**Present:** Mayor Thomas J. Madigan, Committeemen Rudolf E. Boonstra, Timothy E. Shanley, Brian D. Scanlan and Committeewoman Melissa D. Rubenstein

**Also Present:** Township Administrator/Deputy Clerk Robert J. Shannon, Jr., Township Attorney Robert Landel, Thomas Garlick, Esq. and Nancy Cole **Absent:** Municipal Clerk Joyce C. Santimauro

Mayor Madigan opened the meeting for the ten (10) minute public comment period, two (2) minutes per speaker for public comment on any governmental issue that a member of the public feels may be of concern to the residents of the Township of Wyckoff, with a motion from Committeeman Scanlan, seconded by Committeeman Shanley.

 Lynn Weston, 249 Meadowbrook Road thanked everyone who supported the Gay Pride Flag and made comment that with all the hatred in our country, the Gay Pride Flag should be flown as an expression of goodness.

Mayor Madigan explained that the governing body appointed a subcommittee to address the request to fly the Gay Pride Flag. The subcommittee will provide a report this evening. Then, the Township Committee will deliberate on their decision.

Committeeman Scanlan motioned to close the public comment period, seconded by Committeewoman Rubenstein with an affirmative voice vote.

Mayor Madigan advised that the Finance Committee has reviewed and signed vouchers.

Mayor Madigan reported that a sub-committee consisting of himself, Committeewoman Rubenstein, Township Attorney Landel and Administrator Shannon was formed. This sub-committee met and worked diligently at three (3) meetings. Their intent was to arrive at a program that would allow the governing body to express government speech but would not be a public forum. The Township wishes to avoid costly litigation which could occur if the process resulted in a public forum.

Mayor Madigan read a Policy of Inclusiveness which the sub-committee developed and are proposing to the governing body for adoption this evening.

Resolution: #19-262 Township of Wyckoff Policy of Inclusiveness

**WHEREAS**, the Township Committee of the Township of Wyckoff adopts the following Policy of Inclusiveness, and;

**NOW THEREFORE BE IT RESOLVED,** by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey that:

The Township of Wyckoff encourages all citizens and entities to interact with all individuals with courtesy, compassion, respect and recognition of everyone's civil rights and inclusiveness as a member of the Wyckoff community.

The Township of Wyckoff adopts a resolution each year to affirm that the Township of Wyckoff treats all individuals for regardless of race, ethnicity, religion, sexual orientation, gender identity, creed, employment, political orientation, education, socioeconomic standing and beyond in a manner consistent with applicable Civil Rights Act of 1964, as subsequently amended, the New Jersey Law Against Discrimination, the Americans with Disabilities Act and basic human decency. The Township of Wyckoff aspires for all citizens to act in the same manner.

Committeewoman Rubenstein thanked the sub-committee members for their effort and hard work. Much thought and emotion were incorporated into this recommendation. The sub-committee feels that the needs of the community have been fulfilled and also have avoided the potential litigation that could result from public forum. Two (2) locations achieve that perspective which include the installation of a tall flagpole at a prominent location.

The location next to the library entrance is the most heavily trafficked facility in Wyckoff. At last meeting, it was reported that residents had made 54,000 visits to the library in the first half of this year. Flying a flag at this location will represent compassion and can be tied into education which the library could provide to our children. The library is also in a location where many children who are involved in the recreation programs and frequent the central municipal playground would be able to view this flagpole.

Mayor Madigan prefers the second location which is across from the ambulance building but before the library entrance. However, Mayor Madigan finds both locations acceptable.

Committeeman Scanlan thanked the sub-committee and expressed his appreciation for all their work. One (1) concern is that the flag may not be visible at the library location from Franklin Avenue. As an alternate, Mr. Scanlan suggested the entrance to the Wyckoff Community Park on Wyckoff Avenue. He suggested the policy of government speech would be just as effective at the entrance to the Wyckoff Community Park and in his opinion was a more visible location. Mr. Scanlan advised the majority of the residents in Wyckoff do not use the library however, most residents do drive on Wyckoff Avenue. Mr. Scanlan commented that the public speakers who presented "moving" comments at the previous meetings regarding young people contemplating suicide as they struggled with their identity would find this location more visible and a stronger message of support. Mayor Madigan advised that the subcommittee explored multiple locations including Wyckoff Community Park, Zabriskie Pond Park, the Pulis Recreation Complex, the Wyckoff Public Library, the grass median at Main Street and Wyckoff Avenue and the Larkin House. However, the sub-committee felt the two (2) referenced locations provided the most optimum visibility and most heavily traversed areas in the community.

Committeeman Boonstra thanked the four (4) members on the sub-committee for their very genuine report. He would support either of the two (2) recommended locations however, Mr. Boonstra leans to the location just past the library due to the educational aspect that could be tied into the library at this location. An alternate choice location could be the parking area at Zabriskie Pond Park due to the high traffic volume. However, Mr. Boonstra was not in favor of the Wyckoff

Community Park location because the Township's Official Community 9-1-1 Memorial and the American Flagpole are located here. Mr. Boonstra is partial to having the flagpole on the municipal campus because a municipal employee will have to maintain the raising, lowering and changing of the flags contemplated to express government speech.

Committeeman Shanley reported that he just returned from California and suggested the Wyckoff Community Park several meetings ago. However, Mr. Shanley believes the library location would work best as it lends itself better each year for a ceremony. And there is adjacent and convenient ample parking on the municipal campus. Mr. Shanley also recommended the Township fly a flag to support pediatric cancer awareness based on the impact pediatric cancer has had in our community.

Committeewoman Rubenstein advised that when children attend middle school and the regional high schools, those students can be educated as well and not just viewing the flag as a symbol of support. The children who utilize the recreation fields and the library (which is extensive) will see the flag. The first graders are brought to the library to receive their library card and in the first half of 2019, the library experienced 54,000 visits to the facility. The library will help educate them which is an enhancement to simply drive past the flag.

Township Attorney Landel stated that he has been coming to Town Hall for many years and has never noticed the flags in front of Town Hall due to the mandatory concentration level required when driving on busy Franklin Avenue. The location by the library enjoys greater foot traffic thereby an enhanced visual of the flag.

Committeeman Scanlan noted that the Wyckoff Community Park location is next to the municipal park & ride facility at the Cornerstone Christian Church and as such, generates significant foot traffic also.

It was mentioned that locating the flagpole behind Town Hall may send the wrong message. It was further indicated that the Township is not permitted to fly the flag at the schools where there would be the greatest visibility to young people. However, the library provides the next best location.

Committeeman Scanlan expressed a concern that flying the Pride Flag and also flags of concerns related to diseases diminishes the message of the Pride Flag. Committeewoman Rubenstein advised that that is an absurd and contrarian comment and that it was not the intention of the sub-committee who worked extremely hard and long to achieve the best decision as per the comments that were rendered by the public in previous meetings. Mr. Scanlan stated he realized it was not anyone's intention but it could be a perception.

Mayor Madigan indicated the Township reviewed all the proclamations that the Township Committee adopted last year and chose proclamations that add a theme or event that was important to the community. It was mentioned it is the governing body's job to educate the public on our policies. Our policy is to express government speech on matters of importance and timely to the municipality. Some of those matters include pediatric cancer awareness since it has impacted our community.

In the month of May when Memorial Day is celebrated, the report reflects a flag that recognizes our fallen heroes as well as our veterans. Additionally, this year, the Township displayed a banner at the Larkin House and placed rainbow ribbons on flagpoles as was done in 2017 whereby Committeeman Scanlan voted against them. Mr. Scanlan responded that he was the Mayor in 2018 and 2018 was not the 50<sup>th</sup> Anniversary of the Stonewall Riots. That was the catalyst that drove this issue this year. Mr. Scanlan's reason for not voting for displaying the ribbons is that he believed it was an action to forestall the posting of the Pride

Flag. As it relates to the banner at the Larkin House, Mr. Scanlan did not vote no, he abstained.

Mayor Madigan pointed out that in 2017, Wyckoff resident Sara DeRico suggested and was permitted to place rainbow ribbons on the lamp-posts within the Town Hall Complex.

At this point, Mayor Madigan suggested that the Township Committee deviate from this evening's agenda and open the meeting for public comment.

Committeeman Boonstra motioned to open the public comment period, seconded by Committeewoman Rubenstein with an affirmative voice vote.

- 1. Lisa Eidel, 408 Buckingham Circle thanked the Township Committee and sub-committee for their work and recommendation. When the public met with the governing body in June, the 40% rate of gay suicides among gay individuals was the concern. Ms. Eidel expressed the belief that posting the flag on a main thoroughfare would be more beneficial. However, she is amenable to the idea of placing the flagpole at the library with an education approach but agrees with Committeeman Scanlan that the Wyckoff Community Park (next to the park & ride facility) has more visibility. Ms. Eidel opined that the target audience is not the younger children who would visit the playground and she is not sure many of the children struggling with their identity participate in recreation programs. Ms. Eidel is aware that the sub-committee was not trying to equate breast cancer with the pride flag, but she understood the concern regarding flying the Pride Flag on the same pole as flags for medical diseases. Ms. Eidel stated she is a lesbian, her cousin was gay and committed suicide. Please make the other months celebratory and educational and not necessarily disease awareness oriented.
- 2. Gerry Weston, 249 Meadowbrook Road thanked the sub-committee and the governing body and described their report as an excellent compromise. Mr. Weston would be in favor of the library location. Committeeman Shanley interjected to advise that the governing body has also obtained an Open Space Grant to install walking paths through the complex in that area to increase foot traffic.
- 3. Sara Derico, 190 Wyckoff Avenue thanked the sub-committee for their work and stated she understands the location of the library and the educational component however, that location may miss the age group. She prefers the Wyckoff Community Park location due to its proximity to the park & ride facility. Ms. DeRico suggested the Township Committee add a few additional flags that celebrate educational events such as Black History Month in February.
- 4. Erica Kao, 529 Helena Avenue thanked the sub-committee for developing a recommendation in a timely manner.

Committeeman Boonstra motioned to close the public comment period, seconded by Committeeman Shanley with an affirmative voice vote.

Mayor Madigan then suggested that the resolution entitled Policy of Inclusiveness and the resolution known as Policy on new Flagpole and Government Speech which places a new flagpole in the municipal campus at the library entrance to be added to this evening's business agenda and for each resolution to be considered separately and not on the Consent Agenda. A governing body consensus appeared to exist to approve this suggestion.

Committeeman Scanlan suggested a modification to one (1) of the resolutions to require that when a flag is flown, an appropriate public service announcement is issued to correspond and placed on social media accounts. The governing body discussed this suggestion and were of the opinion that including this modification in the resolution is unnecessary and might be interpreted as a public forum. The Township already issues and/or posts proclamations of significance on its website. Therefore, a consensus appeared to exist not to modify the resolution in that regard.

### Resolution #19-263 Policy on new Flag Pole and Government Speech

**WHEREAS**, the Township Committee of the Township of Wyckoff adopts the following Policy with respect to a New Flag Pole and Government Speech.

**NOW THEREFORE BE IT RESOLVED,** by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey that:

The Township of Wyckoff recognizes that community and civic engagement is best fostered through public and unambiguous communication with its citizens.

The Township of Wyckoff also recognizes that flags have for time immemorial been an effective way for government to communicate with its citizens.

The Township of Wyckoff shall construct a flagpole within the Municipal Campus at Block 258 Lot 1. The flagpole will be located in Memorial Field just past the entrance to the Library parking lot off of Woodland Ave. This location has been chosen since it constitutes a central location of community recreation being directly adjacent to the municipal playground, recreational fields and the township's free public library. The site receives significant pedestrian and vehicular traffic and sits at a high elevation within the municipal campus which will provide for optimal visibility. The site will allow for the communication of both the sovereignty of the Township of Wyckoff and various messages the Township of Wyckoff chooses to express.

The Township of Wyckoff shall fly atop this flagpole the official flag of the Township of Wyckoff, to be designed at the discretion of the Township, that shall generally bear the official seal of the Township of Wyckoff. Below the official flag, the Township may fly a flag or flags that communicate a position or principal espoused by the governing body of the Township of Wyckoff through Township Committee resolution. Such a flag or flags may be flown for a limited period of time to be determined by the Township Committee.

A plaque shall be placed at the base of the flagpole which states the following: "The Township of Wyckoff establishes this flagpole as a means of communicating messages of support, recognition, and acceptance, from the municipal government to its citizens and to all who bear witness."

The Township of Wyckoff declares the flag pole and general area around the flagpole, including but not limited to the grounds of the Wyckoff Public Library and field adjacent, shall not be a public forum and is designated as property for the purpose of government speech so that this government's message to the people is clear, unambiguous and without confusion.

Review of the 8:00 p.m. Agenda:

1. The Administrator reported that this evening's agenda includes three (3) ordinances for introduction. Ordinance #1883 is required by the New Jersey

DEP regarding the flood damage prevention ordinance which allows property owners to purchase flood insurance once this ordinance is adopted.

- 2. Ordinance #1884 addresses a requirement to connect to the public sanitary sewer when a property is within 100 feet of an active sanitary sewer within a certain time period or before a certificate of continued occupancy is obtained. This ordinance was requested by the Northwest Bergen County Sewer Utilities Authority. Committeeman Boonstra attended a meeting at the Northwest Bergen County Sewer Utilities Authority as part of promoting sewer availability and sewer connections in the Township for the remaining property owners that are not connected to sanitary sewers. This ordinance was an outgrowth of that meeting Mr. Boonstra attended,
- 3. Ordinance #1885 implements the affordable housing zone related to the intervenor's property known as the former Maple Lake Property and is part of the Township's adopted 2018 third round housing element and fair share plan.
- 4. The agenda also includes a closed session discussion this evening requested by the Township Attorney.
- 5. Committeeman Shanley suggested the date of the fireworks fundraiser be listed on the agenda under "motions" to approve the event for Saturday, September 28, 2019. A discussion resulted in that the following day Sunday, September 29, 2019 is the start of Rosh Hashanah at sundown. Therefore, there will be no rain date for the fireworks display.

At 8:07 p.m. the Township Committee recesses the Open Work Session discussion of the Open Public Meeting to conduct the Public Business Meeting.

### **Policy Action Items:**

- The Township Committee requested a meeting with Orange & Rockland Utilities regarding the utility company's procedure for turning off electric service to a homeowner, leaving the resident without power.
   Committeemen Scanlan and Shanley will attend this meeting.
- 2. The lease for the PTO Economy Shop will expire later this year. The Administrator requested authority from the governing body to assist Mr. Landel to draft a lease with essentially the same terms and conditions. The Township Committee agreed. Mayor Madigan also advised that the volunteers of the PTO Economy Shop are replacing the lighting and the floor inside the building. All proceeds from this consignment shop benefit the Wyckoff public schools.
- 3. A report was provided to reflect the followers on the Township's social media accounts continues to increase. Due to the national trend of the demise of the local community newspapers, the Township's focus has switched from a public service announcement issued to local newspapers, to social media posts which are consistently placed on the Township's Facebook, Twitter and Instagram accounts as well as the weekly e-news communication.

4. This evening was the second night that the governing body is videotaping its Township Committee Meetings. The Administrator has assembled all the Township Committee's transparency enhancements entitled "Easy Public Access for Residents." The governing body has achieved these improvements over the past number of years. They have been inventoried and in the interest of time, will be stated in the meeting minutes.

### TOWNSHIP OF WYCKOFF'S MUNICIPAL MATTERS

#### 10 PART PROGRAM FOR EASY PUBLIC ACCESS

- 1. Township Committee <u>meeting agendas</u> and the <u>resolutions</u> and the <u>ordinances</u> listed on those meeting agendas for action are posted on the Township's web site (Wyckoff-nj.com) <u>on the Friday before the Tuesday night meeting</u> (4 days prior to the Township Committee meeting).
- 2. The Planning Board and the Zoning Board of Adjustment meeting agendas are posted on the Township of Wyckoff website (wyckoff-nj.com) on the Friday prior to the Wednesday Planning Board meeting and on the Friday prior to the Thursday Zoning Board of Adjustment meeting. ADDITIONALLY, the meeting agendas include a parenthetical explanation in "non legal" terminology of the purpose of each land-use application in common vernacular.
- 3. Meeting minutes of the Township Committee meetings, Planning Board, Zoning Board of Adjustment, Board of Health, Parks and Recreation Advisory Board, and Environmental Commission are posted on the Township's website the day after the meeting at which they are approved. For the Township Committee, that means every fifteen (15) days the Township Committee meeting minutes are posted and for all other boards, since they meet once a month, their meeting minutes are posted every thirty (30) days. At minimum, three (3) years of meeting minutes are posted) and available for easy public access 365/24/7.
- 4. When the Township Committee introduces an ordinance, it is permitted to publish only the title of the ordinance in the Ridgewood News. Although this is legal, it is impossible for a citizen to understand the ordinance. The Wyckoff Township Committee publishes each ordinance in its entirety to allow citizens to gain an understanding of the ordinance and its impact or purpose from reading the publication in the newspaper.
- 5. Effective July 2019, the Township Committee began <u>video recording</u> its bi-monthly meetings and posting those video recordings on its web site in the same location that written meeting minutes are located for easy public access 365/24/7.
- 6. The Township's website homepage includes a <u>prominent link</u> titled, "Legal Notices from the Municipal Clerk" which contains a listing of each legal notice as it is published and which links to each complete legal notice of the Township Committee such as; bid notices and ordinances, for easy public access 365/24/7.
- 7. The Township's website includes a <u>prominent</u> link titled, "Municipal Records" where financial records, collective bargaining agreements and elements of the Township's Master Plan are located for easy public access 365/24/7.

- 8. The Township's website includes a <u>prominent</u> link titled, "Township Laws and Codes" which provides all laws of the Township of Wyckoff, such as; the zoning codes, subdivision and site plan codes, property maintenance code and the traffic code all located in one place for easy public access 365/24/7.
- 9. The Township's website includes a <u>prominent</u> link titled, "Request a Service". Over 204 requests have been submitted as of July 1, 2019. All requests have received a reply. The Township expects to service more than 400 requests in 2019.
- 10. The Clerk's office has received 301 public records requests (OPRA) to date as of July 1, 2019. Last year (2018) the Clerk's office replied to 659 records requests and the Township expects to satisfy a similar number of requests by years end. 95% of these records requests are replied to in 3 of the allowable 7 days permitted by law. For a historical perspective, 665 record requests were provided in 2017 and 536 record requests were provided in 2016 and Open Public Records Act (OPRA) request forms can be found on the Township's web site and submitted directly using our online form platform for easy public access 365/24/7.
- Mayor Madigan expressed sympathy on behalf of the Township due to the passing of Margaret Craig. Ms. Craig was a member of the Wyckoff K-8 Board of Education, Founding Member of the PTO Economy Shop, Founding Member of the Flow Follies at Ramapo High School and a longtime volunteer including being recognized by the Wyckoff Family YMCA as a Woman of the Year. Committeeman Boonstra served with Ms. Craig on the K-8 Board of Education also expressed his condolences.

### **Township Attorney Report:**

- Mr. Landel has communicated with the Township's Labor Counsel and provided him with the lease for the 691 Wyckoff Avenue property and he is researching any sub-contracting at the site.
- Mr. Landel is working on the shared service agreement between the Township and the County of Bergen for the use of Bergen County's pickup truck to tow the rescue boat and trailer which are the subject of a different shared service agreement.
- The Township Attorney has obtained a time extension to respond to a legal matter where a resident is opposing the Police Chief's denial of returning a firearm.
- 4. Mr. Landel's Staff has reached out to the property owner but he is still awaiting a copy of the signed contract for the purchase of 240 Demarest Avenue.
- 5. The review and drafting of an ordinance amendment has been completed regarding several pre-existing uses that Committeeman Shanley requested clarity on. An applicant's attorney has disagreed with the Township Engineer's interpretation of the Township Code. That draft ordinance will be in this Friday's Township Committee packet for review.

### **Township Committee Reports:**

#### **Brian Scanlan:**

- Mr. Scanlan drafted a letter to the President of the New Jersey Board of Public Utilities regarding Orange & Rockland's poor service and is ready for the Mayor's signature. The letter will be mailed later this week.
- 2. Mr. Scanlan and Committeeman Boonstra will be conduct interviews of the applicants who wish to volunteer as a member of the Historical Preservation Committee.
- Mr. Scanlan congratulated Administrator Shannon and Chief Financial
  Officer McLeod after reading the 113 page Annual Report of Audit.
  Again, there are no recommendations for financial practices improvement which is exceptional.

### **Timothy Shanley:**

- The Appellate Court denied the appeal in the Ridgewood Water Litigation.
   A complete summary will be provided in Closed Session this evening by the Township Attorney.
- 2. On Thursday, August 15, 2019 at 7:00 p.m. the Fireworks Sub-Committee will conduct their third meeting.
- 3. The Recreation Advisory Board did not meet this month. Mr. Shanley asked the Administrator to explore lightning detention systems for the Pulis Soccer Complex, Memorial Field Complex and Wyckoff Community Park.
- 4. Mr. Shanley was approached by a member of the Wyckoff Education Foundation requesting that the foundation would be approved to raffle off an opportunity for a school child to be "Police Officer for a Day" at the Wyckoff Police Headquarters. The governing body members who serve on the Police Committee expressed apprehension with using the police department as a fundraiser. The Administrator suggested the Wyckoff Education Foundation could possibly raffle off a roster slot for next year's Junior Police Academy.
