October 17, 2015 is the Health Fair and Influenza Prevention Program at Eisenhower School from 10:00 a.m. – 3:00 p.m. in the Cafeteria. The Mayor's Wellness kickoff and Stigma Free program will be incorporated into this year's Health Fair. Vendors should enter through rear gate off Drury Lane. CERTs have been requested to assist at the Drury Lane gate, help vendors getting supplies to Cafeteria and staffing a CERT table as part of the Health Fair.

Ms. Coffey stated that as part of the Stigma Free program, college students will be returning back to Ramapo and Indian Hills High Schools to talk about the transition from high school to college.

Dr. Morski reminded members of the following Open Public Records Act (OPRA) Law requirements. Board members must include the following language on all memos to board members:

"The Board/Commission Secretary or Liaison shall be included in any email a Township Committee appointed Board/Commission member sends. All emails are subject to the Open Public Records Act and as such, may be requested by citizens. (This requirement is applicable to all members of the Wyckoff Planning Board, Zoning Board of Adjustment, Library Board of Trustees, Recreation and Parks Commission, Board of Health, Environmental Commission, Shade Tree Commission, Design Review Advisory Committee and any other ad-hock committee regardless if it is sent from your personal/business computer or personal/business data phone.) There should be no expectation that the content of emails exchanged with municipal officials and employees will remain private."

Donna Garbaccio motioned to close the Public session; seconded, Steve Clarke; all members present voting affirmatively.
