- Chair Shugarman said that on Friday, October 9, 2015 ANJEC awarded the 3 town FLOW alliance, which coordinates the FLOW Green Film Festival, an Environmental Achievement Award. JR Frank informed the Commission that the 2016 Green Film Festival committee is considering changing the program, offering the films in the month of April with 2 films on Thursday evenings and 2 films on Sunday afternoons to encourage greater participation.
- The Monarch Butterfly Way Station at Russell Farms was launched on Tuesday, October 20 with a ribbon cutting ceremony at 4 p.m. Commissioner Key said the Girl Scouts gave a special presentation. Chair Shugarman said as stated in the ANJEC grant, a significant percentage of the \$1,500 grant will go towards the monarch butterfly brochures.
- The Wyckoff Shredfest, a town wide opportunity for residents to recycle their personal paper documents through shredding, was held on Saturday, October 24, 2015. Commissioner Wiederhold and Commissioner Hoogerheyde reported there was a great turnout of volunteers and approximately 270+ cars came through the line with materials to be shredded.

IV New Business

- The Committee discussed the need to update the 1995 Natural Resource Inventory for Wyckoff and was informed by the Township Administrator after review of the referendum question that, the Open Space Fund Ordinance does not allow for funds to be used to fund a consultant to write an Environment Resource Inventory. Chairman Shugarman asked the Commissioners to share their views and specific recommendations on a Natural Resources Inventory. With the assistance of Commissioner DePhillips, the WEC made the following two recommendations to the Township Committee: a request that the Township Committee update the 1995 natural resource inventory and that the WEC be consulted and provide input while the inventory is being written. Also, in the future the WEC would like to be consulted with respect to the expenditure of Open Space Funds or any proposed expenditures that would be permitted under the Open Space Fund. Commissioner Reynen seconded this motion.
- The Commission also had brief discussions on the lack of a tree ordinance in the Township. This issue will be tabled for a further discussion in the New Year.
- Commissioner Reynen revisited an earlier discussion regarding limited public information on what travels on freight trains passing through the township.
