### **III Environmental Commission (Green Team) Activities/Programs/Grants for 2015**

#### **Upcoming and Past Events**

- Open Space Trust Fund – Chair Shugarman said the Township Committee is considering an ordinance tonight to use \$300,000 of the green space tax funds to complete the Pulis Field Recreation Complex.
- The WEC discussed the dates for Team Up to Tidy Up (TUTU) in 2016. The Commissioners confirmed the date as Saturday, April 16, 2016 with a rain date of Saturday, April 23, 2016 due to the conflict with the public school spring break.
- The launching of the Monarch Butterfly Way Station at Russell Farms will be on Tuesday, October 20 with a ribbon cutting ceremony at 4 p.m. A committee will meet September 29<sup>th</sup> at 3:30 p.m. at Sicomac School to design a monarch brochure which will handed out on October 20<sup>th</sup>.
- The Wyckoff Shredfest, a town wide opportunity for residents to recycle their personal paper documents through shredding, will be held Saturday, October 24, 2015 from 9 a.m. to noon at the Wyckoff DPW Building on West Main Street. Volunteers are requested.
- A PSA has been drafted and posted on the Wyckoff Website and WEC webpage looking for new Green Team members.
- Chair Shugarman said that ANJEC will have an annual forum on Friday, October 9 at 4:30 p.m. at the Raritan Valley Community College. The 3 town FLOW alliance which coordinated the Green Film Festival will be receiving an award. JR Frank suggested the in 2016 the Green Film Festival be moved from Thursday evenings to Sunday afternoons at the Wyckoff Public Library.
- The Mayors Wellness Committee is requesting a representative from the WEC or Green Team Task Force. There will be approximately 4 meetings a year.
- Chair Shugarman said the Bergen County Freeholders adopted a resolution against the Pilgrim Pipeline by a 4 to 1 vote. The Township of Wyckoff has not moved forward with a resolution. The WEC will revisit this subject at next month's meeting.
- Commissioner Reynen announced that a Bergen County Utility Grant of \$1,000 was awarded to Sicomac & Lincoln Elementary Schools.
- Chair Shugarman said Christine Key and John Adams are sending a letter to the WEC student representatives about an independent air quality project at Ramapo HS and an independent water quality project at Indian Hills.
- Commissioner Madigan said that Ramapo and Indian Hills are looking into Green Energy options in order to achieve the necessary points for Sustainable New Jersey.
