Doug Swenson, Chairperson, called the meeting to order at 7:30pm in the West Wing Conference

Historic Preservation Commission Liaison, Rudy Boonstra, read the Open Public Meetings Act statement: "This special Open Public Meeting of the Wyckoff Historic Preservation Commission is now in session.

A 48 hour notice of this meeting was sent to The Record, The Ridgewood News and the North Jersey Herald and News – all newspapers having general circulation throughout the Township of Wyckoff on January 8, 2020. A copy of said notice was posted on the Bulletin Board in Memorial Town Hall and a copy has been filed with the Municipal Clerk,

- 1. Motion by Sarah Caprio, second by Curtis Bajak. All voting affirmatively to approve the meeting minutes from the January 7, 2020 Historic Preservation Commission meeting.
- 2. The Commission discussed the merits of participating in the NJ Certified Local Government program. Potential grants for the use of consultants who specialize in all types of historic preservation activities, surveys and communications. A consensus appeared to exist to submit an application.
- 3. The criteria to establish, for identification of historic sites, buildings, structures, streetscapes and district maps, was thoroughly and carefully reviewed. The criteria for Ridgewood and Millburn (Essex County), the state register for historic places and the Federal Register were all compared and criteria to recognize the agrarian history of Wyckoff was noted. It was also noted that Wyckoff's ordinance #1876 includes suggested criteria for a list of landmarks. More research is required.
- 4. Sarah Caprio discussed the website for the Westwood, NJ Historic Preservation Commission and its ease of use was discussed.
- 5. For the purpose of preserving homes with historical significance as this process develops, suggestions were offered on how to become aware of these properties when they are listed for sale.
- 6. A consensus existed to diligently work on developing one list that indicates which structures are on the NJ Registry and the National Registry and which criteria do they satisfy (a narrative of what features trigger their historical significance.)
- 7. The Chair will contact area Historical Preservation Commissions to inquire on how they approached these tasks and best practices for notification to the property owners.
