## **ORDINANCE #92**

AN ORDINANCE TO AMEND CHAPTER 214 OF THE CODE OF THE TOWNSHIP OF WYCKOFF "SEWAGE DISPOSAL SYSTEMS, INDIVIDUAL" SECTION 214-15 "FEES AND CHARGES" TO AMEND PERMIT FEES FOR THE CONSTRUCTION, RECONSTRUCTION, RENOVATION, ALTERATION AND/OR REPAIR OF INDIVIDUAL SEWAGE DISPOSAL SYSTEMS.

**BE IT ORDAINED,** by the Board of Health of the Township of Wyckoff, County of Bergen, State of New Jersey, that Section 214-15 "Fees and charges" is hereby amended as follows:

**SECTION 1-** Chapter 214, Sewage Disposal Systems, Individual

Section 214-11 Fees and Charges.

- A. The following fees and charges are hereby established:
  - (1) The fee for the filing of an application and engineering data for issuance of a permit for construction and inspection of an individual sewage disposal system shall be five hundred and fifty dollars (\$550.) five hundred and eighty five dollars (\$585.) Said fee shall include reinspection of an individual sewage disposal system or part thereof caused by the failure of the permittee to locate and construct the same in accordance with the requirements of the permit or any written order of a duly authorized agent of the Board of Health; the preliminary permit and final permit as set forth in § 214-11H, Section 17.1(a), (b), (c) and (d); and the certificate of compliance as set forth in § 214-11J, Section 17.6.
- (2) The fee for filing an application for issuance of a permit to reconstruct, renovate, alter, repair or extend any existing individual sewage disposal system shall be four hundred fifty dollars (\$450.) four hundred eighty dollars (\$480.). Said permit shall include reinspection of an existing individual sewage disposal system or part thereof caused by the failure of the permittee to reconstruct, renovate, alter, repair or extend the same in accordance with the requirements of the permit or any written order of a duly authorized agent of the Board of Health.

- (3) To the extent any application, engineering data, plans and submissions submitted pursuant to Section A(1) and (2) above are incomplete or deficient, one hundred and fifty dollars (\$150.00) one hundred sixty dollars (\$160.) fee will be charged for each additional review of the application with new submissions.
- (4) The fee for the issuance of a permit to clean or empty any receptacle used for the reception or storage of human excrement or other putrescible matter shall be five dollars (\$5.00) ten dollars (\$10.).
- (5) The fee for septic component repair shall be fifty dollars (\$50.00) sixty dollars (\$60.).
- B. All fees shall be made payable to the Township of Wyckoff.

**SECTION 2** - All others terms and provisions of Chapter 214 shall remain in full force and effect except as specifically modified herein.

**SECTION 3** - This Ordinance and the fees established herein shall take effect immediately upon final passage and publication as required by law.
