RESOLUTION TO BE MEMORIALIZED

Hajinlian, Noreen 327 Brookside Ave. Block 203 Lot 18 (Minor Subdivision. The applicant proposes to obtain land from adjacent lot 17 of block 203 in order to subdivide her property, lot 18, into two (2) conforming lots).

Board Attorney Hanly stated that he amended the Resolution by adding two (2) additional conditions to the resolution based on Mr. DiGennaro's technical memo dated 11/5/2021. Condition number four (4) has been added which states corrections to drawings and the zoning table need to be filed with the Board Secretary and approved by the Township Engineer prior to recording of the subdivision deeds, and condition number five (5) which states to the extent that the applicant needs approvals from Bergen County, such approvals must be obtained and filed with the Board Secretary prior to recording of the subdivision deeds.

Chairman Fortunato said that he will make sure these conditions are met before he signs the mylar or the final subdivision plan.

Mr. Hanly said that apparently the County is involved because Brookside Avenue is a county road, and the applicant should have mentioned that at the application hearing.

Mr. Homaychak made a motion to approve the Resolution as amended. Second, Mr. Sedita. Voting in favor: Ms. Conlon, Mr. Sedita, Mr. Homaychak, Mr. Fisher, Mr. Purvin, and Chairman Fortunato.

A motion to adjourn the Work Session meeting was made, seconded, and passed unanimously. The Work Session concluded at 7:45 p.m.
