AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK

WHEREAS, the Local Government Cap Law, N.J.S. 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to

2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Committee of the Township of Wyckoff in the County of Bergen find it advisable and necessary to increase its CY 2020 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Committee hereby determines that a 1.0% increase in the budget for said year, amounting to \$147,011.06 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Wyckoff in the County of Bergen authorized membership of this governing body affirmatively concurring that, in the CY 2020 budget year, the final appropriations of the Township of Wyckoff shall, in accordance with this ordinance and N.J.S. A. 40A:4-45, be increased by 1.0% amounting to \$147,011.06 and that the CY 2020 municipal budget for the Township of Wyckoff be approved and adopted in accordance with the ordinance; and,

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and,

 - b. Deferred charges and statutory expenditures

- e. Other reserves and non-disbursement items
- f. Any inclusions of amounts required for school purposes
- 2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A. 40A:4-45.3 et seq., are fully met (complies with CAP law).
- 3. That the budget is in such form, arrangement, and content as required by the Local Budget law and N.J.A.C. 5:30-4 and 5:30-5.
- 4. That pursuant to the Local Budget Law:
 - a. All estimates of revenue are reasonable, accurate and correctly stated,
 - b. Items of appropriation are properly set forth
 - c. In itemization, form, arrangement and content, the budget will permit the exercise of the comptroller function within the municipality.

#20-163 Introduction of 2020 Municipal Budget

Wyckoff Municipal Budget Adopted Limiting Increase to Less Than 4/10 of 1 Cent

The Wyckoff Township Committee introduced the 2020 municipal budget on March 17, 2020. The Township Committee, led by Committeepersons Melissa D. Rubenstein and Thomas J. Madigan, worked diligently to limit the growth of the budget and provide a stable tax rate despite requirements to address uncontrollable expenses such as state mandated pension costs and employee health care costs. The impact on the average home (assessed at \$793,800) is \$28.58 for 2020. The tax rate increases 4/10th of 1 cent per \$100 of assessed valuation. The 2020 budget totals \$20,087,460 with a tax levy increase of \$366,749. The municipal budget is within the budget cap and the 2% allowable tax levy cap.

Service and Safety Investments

In 2020, the budget reflects a decision to invest in the Township's infrastructure. It includes funds allocated for road resurfacing and replacing DPW rolling stock which has reached the end of its useful life. To comply with State and Federal mandates, firefighter safety equipment such as personal protective gear and self-contained breathing apparatus for search and rescue are funded. Pedestrian safety improvements and

traffic calming devices will be deployed for enhanced pedestrian safety. They include solar powered flashing signals at the following crosswalks located near our elementary schools: 1) Grandview and Coolidge Terrace, 2) Wyckoff Avenue and Circle Drive, 3) Sicomac Avenue and Terhune Terrace, 4) Monroe Avenue and Van Houten Avneue, and 5) Franklin Avenue and Mason Avenue. Traffic calming, "Please Slow Down", when their vehicle exceeds the speed limit and, "Thank you for Driving at or Below the Speed Limit" electronic message signs will be installed at Coolidge, Sicomac, Washington and Lincoln Schools. The budget includes the purchase of two (2) hybrid police patrol vehicles. Environmental benefits will be achieved through reducing the carbon footprint via reduced idling emissions and reduced fuel consumption. In addition, technology advancements for the uniform construction code

which will help to improve efficiency.

The Finance Committee held flat the standard operating expenses, as compared to last year's levels, to compensate for service and safety investments.. The Township Committee appreciates the efforts of our Department Managers who worked with us in reviewing every line item of the budget to justify their need for taxpayer money to provide services to our community. Our Department of Managers worked hard to minimize expenditures and assisted the Township Committee to hold down operating expenses.

(UCC) office and a program to digitize permits will be continued this year

The Finance Committee reviewed every line item of the budget in order to justify each proposed line item of expense in order to help control the growth of expenditures. No changes to the current Township provided services are planned.

Maintaining Priorities

The Township Committee continues its efforts to control the increase in expenditures, pursuing positive fiscal operation such as seeking grants from all levels of government and reducing operating costs through competitive bidding and shared services. Cost reductions and enhanced technology have been realized by regionalization with the Township's many Shared Service Agreements, which includes: 911 dispatch services, Board of Health services with the Bergen County Health Department, fuel facilities and vehicle maintenance services to the Wyckoff Board of Education, strategic purchasing through Northwest Bergen Cooperative Purchasing Consortium and the Wyckoff, Oakland, Franklin Lakes (WOLF Group) shared services group. A new shared service for Court Administrator and Violations Bureau Services was implemented with Glen Rock, resulting in a reduction of one full-time position.


THE TOWNSHIP COMMITTEE ONLY ESTABLISHES THE MUNICIPAL PORTION OF TAXES

Diana McLeod, the Township's Chief Financial Officer, also points out that municipal taxes represent only a portion (14%) of a Wyckoff property taxpayer's obligation. Three separate governmental entities adopt their own budgets funded by taxes. They are: the Bergen County government, the K-8th Local Public School District and the Ramapo-Indian Hills Regional High School District. Two tax levies: The Bergen County Open Space Tax and the Municipal Open Space Tax are approved by voter referendum. The Wyckoff Free Public Library Tax is a separate tax levy;

however, it is included in the municipal budget total and represents 8% of the municipal budget. The county taxes, K-8th local grade school taxes and regional high school taxes have not yet been determined. Although a resident's tax bill reflects all seven separate taxes, the Township Committee is involved in the municipal budget and tax levy portion only and has no involvement in determining the other budgets nor the determination of the six other tax levies. State fiscal laws require the Township's municipal government to serve as the billing and collection agency for all six separate taxes including the Wyckoff Free Public Library tax. She said the sum of all seven of these tax rates ultimately determines the total property tax rate for the year.

<u>Additional Parameters That Guided Finance Committee Members,</u> Melissa D. Rubenstein and Thomas J. Madigan

- This is a budget developed with the taxpayer in mind.
- We worked diligently with approximately 7 meetings to deliver this budget with a focus on delivering residential services at a marginal tax increase of \$28.58 on an average residential assessment of \$793.800.
- Technology investments, including Cyber Security, were made where we can demonstrate efficiency and/or economic gains.
- The budget is being introduced within the State mandate deadline.

I Resolutions (Adoption of the following):

#20-156 National Nutrition Month

WHEREAS, March of each year is designated as "National Nutrition Month" as nutrition education and information campaign, sponsored by the American Dietetic Association, which focuses attention on the importance of making informed food choices and developing sound eating and physical activity habits; and.

WHEREAS, food is the substance by which life is sustained; and,

WHEREAS, the type, quality and amount of food that individuals consume each day plays a vital role in their overall health and physical fitness; and,

WHEREAS, there is a need for continuing nutrition education and a wide-scale effort to enhance healthy eating practices; and,

WHEREAS, experts agree that inactivity and poor eating habits contribute to obesity. Nearly one-third of the country's children ages four (4) to nineteen (19) eat fast food every day, resulting in approximately six (6) extra pounds per year, per child. Fast food consumption has increased fivefold among children since 1970; and,

WHEREAS, the State must take whatever action it reasonably can to facilitate efforts to reduce the epidemic of overweight and obese children and adolescents and the attendant health consequences in this country by promoting preventative health and fitness strategies for overweight and obese children and adolescents to include awareness of proper nutrition, diet and exercise.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey do hereby proclaim the month of March as "National Nutrition Month."

#20-157 National Public Health Week

WHEREAS, the week of April 6, 2020 thru April 12, 2020 is National Public Health Week; and,

WHEREAS, there is a significant difference in the health status of individuals with different abilities and demographics, such as obesity, poor mental health and infectious disease, of people living in the healthiest States compared to people living in the least healthy States; and,

WHEREAS, according to the National Academy of Medicine, despite being one of the wealthiest nations in the world, the United States ranks below many other economically prosperous and developing countries with respect to measures of health, including life expectancy, infant mortality and maternal mortality rates; and,

WHEREAS, life expectancy for the Unites States population declined for the second year in a row and the leading causes of deaths are among the most common, costly and preventable of all health problems; and,

WHEREAS, the value of a strong health system is in the air we breathe, the water we drink, the food we eat and the places where we all live, learn, work, worship and play; and,

WHEREAS, public health organizations use National Public Health week to educate the public, policymakers and public health professionals on issues that are important to improving the health of the people of the United States; and,

WHEREAS, in communities across the United States, people are changing the way they care for their health by avoiding tobacco use, eating healthier, becoming more physically active and preventing unintentional injuries at home and in the workplace; and,

WHEREAS, the Township of Wyckoff's website (wyckoff-nj.com) under "**Board of Health**" provides public health resources and information designed to promote the public health of the Wyckoff Community.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey that they recognize April 6-12, 2020 as National Public Health Week and thank the members of the Wyckoff Board of Health for their dedicated service.

WHEREAS, the Township of Wyckoff operates as the lead agency for a cooperative pricing system for the municipalities of Wyckoff, Franklin Lakes and Oakland; and,

WHEREAS, the Township of Wyckoff acting as the lead agency has captured competitive pricing for many firefighting items resulting in cost significantly less than the price paid in previous years when advertised sealed competitive bidding was not performed; and,

WHEREAS, the Township of Wyckoff intends to utilize advertised sealed competitive bidding to obtain the "lowest price" that meets the requirements of the request for Globe turn-out firefighting gear, Lion firefighting turn-out gear and, FIRE-DEX firefighting turn-out gear; and,

WHEREAS, the Township Committee received and carefully considered a certification dated March 9, 2020 in accordance with NJSA 40A:11-13(d); and,

WHEREAS, the Township of Wyckoff has complied with NJAC 9:34-9.1(d); and,

WHEREAS, the Township Attorney has reviewed this procurement and concurs.

#20-166 Public Health Measures

WHEREAS, on January 30, 2020 the World Health Organization designated the novel Coronavirus (COVID-19) outbreak as a Public Health Emergency of International Concern; and,

WHEREAS, on January 31, 2020 the United States Health and Human Services Secretary declared a public health emergency for the entire United States to aid the nation's healthcare community in responding to the COVID-19; and,

WHEREAS, the Governor has declared that the spread of COVID-19 within New Jersey constitutes an imminent public health hazard that threatens and presently endangers the health, safety and welfare of the residents of one or more municipalities or counties of the State; and,

WHEREAS, as of this date, 61 presumptive positive cases both travel-related cases and community contact transmission of COVID-19 have been documented in Bergen County; and,

WHEREAS, the spread of COVID-19 in New Jersey at a rate comparable to the rate of spread in other affected areas, would greatly strain the resources and capabilities of county and municipal governments, including public health agencies, which provide essential services for containing and mitigating the spread of contagious diseases, such as COVID-19; and,

WHEREAS, on March 9, 2020 the Governor of the State of New Jersey has declared the concurrent invocation of both a State of Emergency pursuant to N.J.S.A. App.A.:9-33 et seq. and a Public Health Emergency as contemplated by N.J.S. A. 26:13-1 et seq., which action invoked the authority and powers contemplated by N.J.S.A. 26:13-3, the Emergency Health Powers Act; and,

WHEREAS, on March 10, 2020 the State of New Jersey recorded its first death attributed to COVID-19 and accordingly the County will implement more aggressive mitigation measures in conjunction with the current containment efforts to combat COVID-19; and,

WHEREAS, the Township is working with State and County officials and authorities on a daily basis on prevention and mitigation activities that include providing critical information to the public about COVID-19 to provide facts and avoid unnecessary fear, training emergency responders and health professionals about the disease and investigating suspected, presumptive and confirmed cases; and,

WHEREAS, Bergen County provides the services of Health Officer to the Wyckoff Board of Health and both along with the Bergen County Office of Emergency Management are providing the Township with assistance; and,

WHEREAS, the Center for Disease Control (CDC) has determined that COVID-19 generally presents a low risk to children, but seniors particularly those with underlying chronic medical conditions are at high risk of serious illness from the disease; and,

WHEREAS, the Township may be required to acquire goods and services that may not be currently available in the municipal product inventory or from vendors with whom the Township currently has a contractual relationship in order to protect and maintain the health, safety and welfare of New Jersey residents and visitors and successfully combat the impact of the virus; and,

WHEREAS, the school systems, K-8 and the high school regional district have closed the schools effective 3/13/20 for minimally the next two weeks with a move towards on-line learning.

NOW THEREFORE BE IT RESOLVED AND MEMORIALIZED by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey that the following precautions and actions are authorized in the best interests of the community consistent with the Governor's Declaration of Emergency:

- 1. Authorize the Wyckoff OEM to execute measures to protect the public from the health emergency that exists within Bergen County regarding the Coronavirus (COVID-19).
- 2. All Municipal Departments and partners immediately shall implement any and all infectious disease guidelines and protocols and use all personal protective equipment in connection therewith.
- 3. All Municipal employees shall follow all local, County, State and Federal health recommendations, in addition to Centers for Disease Control recommendations including but not limited to handwashing, sanitizing and basic infection control procedures.
- 4. Township of Wyckoff residents who are seniors, particularly those with underlying health conditions are strongly encouraged to avoid large crowds and large gatherings while COVID-19 remains a threat.
- 5. To combat COVID-19 the Township shall be permitted whenever necessary to procure the necessary goods or services, which are not available under contracts currently in existence with the Township, without complying with the New Jersey Public Contracts Law (N.J.S.A. 40A:11-6 et seq.), including but not limited to the following:
 - To award emergency contracts, including but not limited to emergency contracts and services for purchases of PPE, commodities, services and technology.
 - To procure any supplies or equipment required to ensure adequate sanitization, cleaning or sterilization of any facility or location.

 - All recreation games, practices and events are cancelled as of 3/12/20.
 - All recreation fields are closed to team and group activities as of 3/12/20.
 - The Larkin Senior Citizen House is closed as of 3/12/20.
 - The Library is closed.

#20-167 National Poison Prevention Week

WHEREAS, Congress designated the third full week in March to be National Poison Prevention Week (NPPW) in 1961 and since then this week has helped to raise national awareness of the dangers of potentially poisonous medicines, household chemicals, and other substances; and,

WHEREAS, poisoning is a preventable illness! From the youngest to the oldest, all people and even pets are at risk; and,

WHEREAS, poison centers across the country will focus the public's attention on identifying poisoning hazards at home as well as learning ways to prevent poisoning emergencies; and,

WHEREAS, a poison is defined as anything that is taken in the wrong amount, in the wrong way or by the wrong person; and,

WHEREAS, unintentional poisoning is the leading cause of unintentional injury death in New Jersey outnumbering deaths by motor vehicles and firearms; and,

WHEREAS, drug overdose deaths including those from prescription and overthe-counter medications, as well as illegal drugs such as heroin and methamphetamines remain at epidemic proportions for both New Jersey and the United States; and,

WHEREAS, in approximately 94% of unintentional poison death nationally and 96% in New Jersey, drugs are the poison; and,

WHEREAS, although the majority of reported poison exposures involve children five (5) years old and younger, the majority of poisoning deaths occur in adults aged 20 to 59; and,

WHEREAS, lead poisoning remains a major public health concern. Elevated blood lead levels can cause significant and permanent damage to the health and wellbeing of a young child. There is no safe level of lead. Stop a child's exposure to lead before it causes harm; and,

WHEREAS, the New Jersey Poison Information and Education System (NJPIES), a division of the Department of Emergency Medicine of the New Jersey Medical School of Rutgers, The State University of New Jersey, provides expert advice, drug information, and poison prevention education to NJ residents through the 800-222-1222 Poison Help Hotline; and,

WHEREAS, all services are free, confidential, multilingual and available 24 hours a day, 7 days a week, 365 days a year even during bouts of Mother Nature; and,

WHEREAS, the public can contact a poison expert by calling (1-800-222-1222), chatting (www.njpies.org), or texting (8002221222@njpies.org); and,

WHEREAS, consumers must be aware that e-cigarette devices, hookah pipes and liquid nicotine may contain very high doses of nicotine in enticing colors,

aromas, and flavors – increasing the likelihood that small children and pets will focus their attention on them. These products pose serious risk of poisoning; and.

WHEREAS, poison experts urge residents to use our services as a resource for poison and drug information instead of consulting the internet for information that may not be accurate; and,

WHEREAS, we encourage all residents to program the Poison Help Line 800-222-1222 into home, office, and cell phones because a rapid response can make a difference in preventing serious injury and saving lives; and,

WHEREAS, poison centers help to eliminate thousands of unnecessary and expensive emergency department visits by offering callers access to free, confidential medical advice; and,

WHEREAS, NJPIES is also involved with the state's efforts in homeland defense, counter-terrorism, emergency preparedness and response, bio surveillance, and surveillance for clusters of poisonings and their sources (products, food and beverages, chemicals in the workplace and at home, environmental toxins, drugs and medicine, and animal and insect bites and stings).

TOWNSHIP OF WYCKOFF ORDINANCE #1906

AN ORDINANCE TO AMEND CHAPTER 42, "INDEMNIFICATION AND DEFENSES," OF THE CODE OF THE TOWNSHIP OF WYCKOFF, SECTION 42-4, "EXCEPTIONS"

BE IT ORDAINED by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey, that the Code of the Township of Wyckoff is amended at Chapter 42, "Indemnification and Defenses," Section 42-4, "Exceptions."

SECTION 1 - Chapter 42, "Indemnification and Defenses," Section 42-4, "Exceptions" shall be amended as follows:

§ 42-4 Exceptions.

The provisions of § 42-3 shall not be applicable when the Township Committee determines that:

- A. The act or omission was not within the scope or incidental to the duties of the public official.
- B. The act or failure to act was the result of actual fraud, willful misconduct or actual malice.
- C. The defense of the action or proceeding would create a conflict of interest between the Township and the public official.
- D. The defense of the action or proceeding is provided for by an insurance policy or policies, whether obtained by the Township or by any other person or entity.
- E. Where the public official has acted in a position of conflict of interest with the municipality.
- F. Where the action has been brought by the municipality itself against the public official, or where the action is a criminal proceeding.
- G. The defense is deemed inappropriate by the Township Committee pursuant to the authority contained in N.J.S.A. 59:10-4.
- H. The public official has failed to deliver to the Township Committee or Township Administrator within 10 calendar days after the time he is served with any summons, complaint, process, notice, demand or pleading the original or a copy thereof.
- I. The public official has failed to cooperate fully with the defense.

Pursuant to N.J.S.A. 59:10-4, the indemnification and defense provided for in this Chapter shall include exemplary or punitive damages resulting from the employee's civil violation of State or federal law if, in the opinion of the Wyckoff Township Committee, the acts committed upon which the damages are based did not constitute actual fraud, actual malice, willful misconduct or an intentional wrong.

SECTION 2 - All other sections of Chapter 42 shall remain in full force and effect.

SECTION 3 - This Ordinance shall take effect upon final passage and publication according to law.

AN ORDINANCE TO AUTHORIZE AND PROVIDE FOR PARTIAL LAND ACQUISITION FROM BLOCK 203, LOT 1.03 IN THE TOWNSHIP OF WYCKOFF AND TO PROVIDE FOR THE RECEIPT, ACCEPTANCE, AND APPROPRIATION THEREFORE.

WHEREAS, pursuant to the Local Lands and Buildings Law NJSA 40A:12-1 et. seq. the adoption of this ordinance authorizes the Township Committee of the Township of Wyckoff to acquire by transaction real property for recreation, open space and/or conservation purposes; and

WHEREAS, the Township Committee of the Township of Wyckoff desires to complete a land swap for a portion of Block 203 Lot 1.03 as shown on the tax map of the Township of Wyckoff, consisting of approximately 25,377 square feet or .583 acres, for recreation, open space and/or conservation purposes pursuant to NJSA 40A:12-5; and

WHEREAS, the Township of Wyckoff completed engineering and land surveying pursuant to Resolution #19-260 to accomplish the land swap stated herein; and

WHEREAS, the Township of Wyckoff, in exchange for the approximately 25,377 square feet or .583 acres from Block 203, Lot 1.03, shall provide the owner of Block 203, Lot 1.03 with 10,726 square feet or .246 acres from Block 203, Lot 1.02, which said owner currently utilizes for the owner's driveway via an easement previously provided by the Township of Wyckoff;

WHEREAS, the public hearing required for the governing body to consider this ordinance shall also serve as the public hearing for determination by the governing body to use and allocate portions of certain lands in Block 203, Lot 1.02 for the acquisition of portions of certain lands of Block 203 Lot 1.03 as stated herein; and

WHEREAS, the acquisition of 25,377 square feet or .583 acres from Block 203, Lot 1.03 will permit the Township of Wyckoff with additional control of certain waterways and the management of stormwaters; and

WHEREAS, the providing of 10,726 square feet or .246 acres from Block 203, Lot 1.02 to the owner of Block 203, Lot 1.02 the Township of Wyckoff shall alleviate any potential exposure or liability associated with the current driveway

easement; and

WHEREAS, the exchange of lands stated herein are done so without the intention of creating a new buildable lot; and

WHEREAS, the required actions stated herein shall be contingent upon approval by the Wyckoff Planning Board of a Minor Subdivision Application setting forth the exchange of the lands stated herein;

NOW, THEREFORE, BE IT ORDAINED, BY THE Township Committee of the Township of Wyckoff as follows:

SECTION 1. The Township of Wyckoff, in the County of Bergen shall proceed with the acquisition of certain lands, approximately 25,377 square feet or .583 acres of Block 203, Lot 1.03 as shown on the tax map of the Township of Wyckoff, for recreation, open space and/or conservation purposes pursuant to NJSA 40A:12-1 et. seq.

SECTION 2. The cost of implementing said acquisition and improvements set forth in Section 1 shall be paid by the Township of Wyckoff by providing the owner of Block 203, Lot 1.03 with approximately 10,726 square feet or .246 acres from Block 203, Lot 1.02.

SECTION 3. It is hereby determined and stated:

- a. Said purpose is not a current expense. The same is an improvement which the Township of Wyckoff may lawfully make or acquire and no part of the cost of said improvement has been or shall be specifically benefitted.
- b. The exchange of lands stated herein is done so without the intention of creating a new buildable lot.
- c. It is not necessary to finance this authorization by the issuance of obligations by the Township of Wyckoff pursuant to the Local Bond Law of the State of New Jersey.
- d. The required actions of the Township of Wyckoff, in connection with the exchange of the aforementioned lands are expressly contingent upon approval by the Wyckoff Planning Board of a Minor Subdivision Application permitting the exchange of lands set forth herein.

SECTION 4. It is hereby determined and stated that no supplemental debt statement is required to be made and signed in connection with said purpose, since the gross debt of the Township of Wyckoff as defined under the Local Bond Law is not increased by this ordinance, and no obligations in the matter of notes or bonds are authorized by this ordinance.

SECTION 5. This ordinance shall take effect after publication thereof and final passage as required by law.
