## **Open Public Meeting Act Statement**

Deputy Municipal Clerk Shannon read the "Open Public Meeting Act" Statement: "This regular meeting of the Township Committee of the Township of Wyckoff is now in session. In accordance with the provisions of Section 8 of the Open Public Meetings Act, I wish to advise that notice of this meeting has been posted in the lower level of the Memorial Town Hall and that a copy of the schedule of meetings has also been filed with the Township Clerk, and copies of this agenda and the annual notice of meetings, of which this is a part, have been heretofore sent to the Ridgewood News, The Record, and The North Jersey Herald and News all papers with general circulation throughout the Township of Wyckoff. At least 48 hours prior to this meeting the Agenda thereof was similarly posted, filed and mailed to said newspapers."

### **Meeting Open for Public Comment**

Committeeman Shanley made a motion to open the meeting for public Comment; Seconded by Committeewoman Rubenstein. All voted in favor.

Dotty Blakeslee, 21 Lions Street. "Have any of you guys done any research on whether undocumented individuals post a safety threat to individuals in Wyckoff? Have you done any research on the number of arrests of undocumented people? Have you done any research on the cost of holding people if we have to cooperate and we take away the ability of our local police to make that call? Consider the possibility of a car coming through Wyckoff and they rear end somebody and they happen to be poor illegal immigrants and we have to hold them here. Have you considered the cost or whether we have the ability to hold these people? Have you considered any of this? This resolution is ridiculous and baseless; it's unfounded, un-researched."

Casey Colonari, 484 Eisenhower Court. Mr. Colonari asked about the Ridgewood Water law suit and questioned if progress was being made. Mayor Scanlan replied that our attorneys have filed an appeal and we are waiting for a ruling on the appeal.

Denise Colonari, 352 Richard Road. Ms. Colonari thanked the township committee for their service to the community and proudly said she was a teacher at Ramapo High School and that Ramapo was rated the #5 high school in the State of New Jersey in the annual New Jersey Magazine rankings. This was determined, Ms. Colonari said, by AP & SAT scores. She thanked the Ramapo High School teachers, Administration and students for a job well done.

**WHEREAS**, the Township Engineer required Lakeland Bank submit the attached letter that states that Lakeland Bank understands and acknowledges that the return of this surety does not rescind their responsibility to pay their pro-rata share of the interior block parking; and,

**WHEREAS,** the Chief Financial Officer, Diana McLeod, has verified the funds; and.

**WHEREAS,** the Township Administrator has reviewed this resolution and concurs.

**NOW THEREFORE BE IT RESOLVED**, by the Township Committee of the Township of Wyckoff, County of Bergen and State of New Jersey that they hereby concur with the recommendation of the Township Engineer to return the \$10,000.00 driveway cash bond to Lakeland Bank for future ramps and for parking lot striping and to return the \$30,000 cash surety for the implementation of the interior block parking plan based on Lakeland Bank's acknowledgement that the return of this surety does not rescind their obligation and responsibility to
