Open Public Meeting Act Statement:

Township Clerk Joyce Santimauro read the "Open Public Meeting Act" Statement: "This regular meeting of the Township Committee of the Township of Wyckoff is now in session. A discussion ensued about the role of Chairman replacement when the Mayor is not available.

Committeeman Madigan made a Motion to amend the Township Committee By-Laws to eliminate the position of Deputy Chairman/Mayor, to eliminate any expectations for the following year, and if the Mayor is unable to attend a function or chair a meeting, the Township Committee member with the greatest seniority or could be the Chairman or the Chairman position could be rotated. The motion could be finalized after the discussion. Seconded Committeeman Scanlan.

Committeemen Carolan and Madigan referenced the Mayor becoming incapacitated and stepping down and if there was an interim period the senior Township Committee member would be Chair. Administrator Shannon clarified, in the spirit of assistance and clarity, by stating that in any event where the Mayor is present or not, the Township Committee as a whole governs the town; an individual on the Township Committee does not govern the town, the Township Committee governs the town. Mayor Boonstra said an interim Mayor could be appointed in the absence of a Mayor or the Township Committee could select a new Mayor if necessary.

Committeeman Scanlan recommended for the position of Chairman in the Chairman's' absence that the Township Committee could fill in alphabetically or in a systematic way so that the committee members know who would be Chairman; with reference to a public event I think this same policy should apply.

Mayor Boonstra said he would prefer the senior member of the Township Committee Chair a meeting in the absence of the Mayor. With regard to events, it could be incumbent upon the Mayor to ask one of his/her colleagues to attend the event. Committeeman Shanley said he agrees.

Committeeman Madigan said for the Mayor's absence at an event, he agrees with Mayor Boonstra that the Mayor ask a colleague to attend the event; regarding a Township Committee meeting in the Mayor's absence the position could be rotated.

Mayor Boonstra said since there is so much discussion about filling the position of Chairman in the Chairman's absence that perhaps the absence of the Mayor should be discussed at the first expanded Work Session Meeting on January 16, 2018. Most importantly for this evening is the elimination of the Deputy Mayor position so Joyce can amend the Reorganization documents.

Committeeman Madigan restated his motion that effective January1, 2018 per the Township Committee By-Laws that the position of Deputy Mayor be eliminated. Seconded Committeeman Scanlan.

SECTION 1B. Increases shall be effective in two (2) increments with one half of annual increase on January 1, 2018 and the remaining one half of annual increase on July 1, 2018.

SECTION 2A. In addition to their annual salary, each officer shall receive longevity compensation as computed in accordance with employee's years of service and detailed in the employment contract.

SECTION 3. On January 1, 2015, employees began contributions mandated by Chapter 78 or such other laws as may be enacted during the term of the contract governing employee health care insurance contributions and will continue the contributions in accordance with mandated amounts.

SECTION 4. The work period shall begin as of 12:01 A.M. Saturday and end as of 12:00 midnight Friday.

SECTION 5. The officer in charge of the Detective Bureau as assigned by the Chief, shall be paid the sum of \$2,500.00 annually. The amount shall be paid as part of that officer's regular pay and in addition to his base salary. Other Detective Bureau personnel, excepting the officer in charge, regularly assigned to the Detective Bureau by the Chief, shall be paid the annual sum of \$2,000.00.

SECTION 6. Court time, excluding civil court, and excluding regular tour of duty, shall be considered overtime, and shall be compensated at time and one half (1-1/2).

SECTION 7. Each member of the Police Department shall be allowed a clothing allowance of \$875.00 per year.

SECTION 8. Employees authorized overtime shall be paid an hourly wage equal to one and one half (1-1/2) time, after working 40 hours or working in excess of a tour of duty for a day. To compute the base hourly rate of any employee for overtime or other purposes, the employee's base salary plus yearly longevity increment shall be divided by 2080 hours.

ORDINANCE #1845

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 54 OF THE CODE OF THE TOWNSHIP OF WYCKOFF, POLICE **DEPARTMENT**

BE IT ORDAINED, by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey that Chapter 54 of the Code of the Township of Wyckoff, Police Department, be amended as follows:

SECTION 1 Chapter 54-21A is hereby amended to reflect a minimum hourly rate in item (1) and to establish two (2) hour increments after the initial four (4) hour minimum in item 5.

54-21 - Payment

- A. Private employers shall pay to the Treasurer of the Township of Wyckoff such hourly rate as is set forth herein or may be fixed from time to time by resolution of the Township Committee as compensation for such services. The Township shall remit to the member of the Police Department performing such off-duty service a portion of said hourly rate, and the balance shall be retained by the Township for administration, payroll and insurance expenses, all as established by this article or by future resolution of the Township Committee. Off duty rates shall be as follows:
 - (1) Traffic and Security Assignment rate: one hundred and twenty dollars, (\$120) per hour for each officer paid to the Township of Wyckoff, from which the police officer performing the off-duty service shall be paid one and one half times the officer's regular hourly pay but not less than \$65.00 per hour.
- (2) Non-profit organizations, charitable organizations, Wyckoff businesses and Wyckoff residents rate: ninety five dollars (\$95) per hour cost paid to the Township of Wyckoff, of which seventy five (\$75) dollars per hour shall be paid to the police officer performing the off-duty service.
- (3) An additional charge of twenty five dollars (\$25) per hour shall be paid when a police patrol vehicle is required and/or requested for use for the off-duty assignment. The twenty five dollars (\$25) per hour charge shall apply to numbers (1) and (2) above.
- (4) When a traffic safety review meeting is required, a traffic safety review fee shall be paid to the Township of Wyckoff in the amount of seventy five dollars (\$75).
 - (5) A four (4) hour minimum shall be required for each private duty assignment. A minimum of two (2) hour increments after the first four (4) hours.
- B. The Police Department shall require private individuals and/or entities requesting off-duty police assignments to submit payment based on estimates of the work to be performed, in advance of services rendered. The Township will escrow the moneys in the dedicated fund to ensure timely payment to the police officers who performed the off-duty assignment.
- C. Wyckoff sworn officers may work off-duty assignments in a municipality other that Wyckoff in compliance with this section when Wyckoff sworn officers are not required for Wyckoff overtime assignments or off-duty assignment.
- **SECTION 2** Except as herein amended and supplemented, all other provisions of Chapter 54 of the Code of the Township of Wyckoff, Police Department, shall remain in full force and effect.
- $\underline{\textbf{SECTION 3}}$ This ordinance shall take effect immediately upon final passage and publication as required by law.
