2018 Municipal Budget – Public Hearing

Mayor Scanlan invited the Township Committee Members to comment on the 2018 Municipal Budget.

Committeewoman Rubenstein thanked Committeeman Thomas Madigan, Administrator, Robert Shannon and CFO, Diana McLeod for all of their hard work to make this budget possible. It was very nice how everyone worked together and constructively came up with a budget that increases no more than .04% the average amount our residents are going to be paying. Impact of an average home \$787,000 is an increase of \$29.91. Keeping in mind the municipal and open space of our budget is limited to 14%. The budget total is 19,630,198.00 with a tax levy increase of \$234,015.00 the Township is well within the budget cap and the two percent allowable of the tax levy cap. Committeewoman Rubenstein also noted there was only an eight dollar increase for the storms Riley and Quinn which caused a lot of destruction and tree branches down and the DPW is collection the tree branches for the residents of the Township.

Committeeman Shanley also thanked Committeewoman, Melissa Rubenstein Committeeman Thomas Madigan, Administrator, Robert Shannon and CFO, Diana McLeod for a great job well done on the 2018 Municipal Budget.

Committeeman Boonstra thanked the budget committee. He stated had it not been for the damage created by the March winter storms the budget increase for an average home would have been \$21.00. However, the eight additional dollars is well worth it.

"Mayor Scanlan thanked the budget committee for their hard work."

Administrator Robert Shannon also thanked the finance committee for their hard work and I would especially like to point out our CFO, Diana McLeod for the hours and hours she spent on the budget. Administrator Robert Shannon also stated that the New Jersey of Community Affairs has advised the Township that the budget can be adopted this evening.

AN ORDINANCE TO PROVIDE A CERTAIN CAPITAL IMPROVEMENT IN THE TOWNSHIP OF WYCKOFF AND TO PROVIDE FOR THE RECEIPT, ACCEPTANCE AND DEPOSIT OF GRANT FUNDS THEREFORE.

WHEREAS, the Township of Wyckoff has made an application to the State of New Jersey Transportation Trust Fund Municipal Aid Formula Program to receive funds for the reconstruction of a section of Lafayette Avenue, a municipal road in the Township of Wyckoff; and,

WHEREAS, the Township of Wyckoff has been advised it is the recipient of a grant in the amount of \$215,000.00 for reconstruction of a section of Lafayette Avenue; and,

WHEREAS, the Township of Wyckoff, shall enter into a contract with the State of New Jersey Transportation Trust Fund Municipal Aid Formula Program to participate in the receipt of grant funds made available; and,

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Wyckoff, County of Bergen, as follows:

SECTION 1. The Township of Wyckoff, in the County of Bergen shall proceed with the improvement of a section of Lafayette Avenue in the Township of Wyckoff with a New Jersey Department of Transportation Trust Fund Grant for \$215,000.00 and engineering design and construction inspection from the general capital improvement fund.

SECTION 2. The cost of implementing said improvements set forth in Section 1 shall be paid by the Township out of funds to be received specifically for said purpose through the State of New Jersey Transportation Trust Fund Municipal Aid Formula Program.

SECTION 3. It is hereby determined and stated:

- a. Said purpose is not a current expense. The same is an improvement which the Township of Wyckoff may lawfully make or acquire and no part of the cost of said improvement has been or shall be specifically benefited.
- b. It is not necessary to finance this authorization by the issuance of obligations by the Township of Wyckoff pursuant to the Local Bond Law of the State of New Jersey.
- c. The total authorized appropriation in this ordinance is \$215,000.00.

SECTION 4. The monies which the Township of Wyckoff is authorized to receive pursuant to the terms of the New Jersey Department of Transportation Trust Fund Grant shall, when received.

SECTION 5. It is hereby determined and stated that no Supplemental debt statement is required to be made and signed in connection with said purpose, since the gross debt of the Township of Wyckoff as defined under the Local Bond Law is not increased by this Ordinance, and no obligations in the matter of notes or bonds are authorized by this ordinance.

SECTION 6. This Ordinance shall take effect after publication thereof and final passage as required by law.
