Open Public Meeting Act Statement

Deputy Municipal Clerk Shannon read the "Open Public Meeting Act" Statement: "This regular meeting of the Township Committee of the Township of Wyckoff is now in session. In accordance with the provisions of Section 8 of the Open Public Meetings Act, I wish to advise that notice of this meeting has been posted in the lower level of the Memorial Town Hall and that a copy of the schedule of meetings has also been filed with the Township Clerk, and copies of this agenda and the annual notice of meetings, of which this is a part, have been heretofore sent to the Ridgewood News, The Record, and The North Jersey Herald and News all papers with general circulation throughout the Township of Wyckoff. Meeting Open for Public Comment

The Township Committee voted unanimously to open the public portion of the meeting.

Robert Powers, 176 Nancy Lane, Wyckoff – Mr. Powers addressed the governing body and stated he was in favor of reinstituting the vegetative waste curbside collections. Mr. Powers stated he would be willing to paying a nominal fee as a temporary improvement for 2015. A discussion resulted on what may represent a nominal fee, \$100.00 per season was suggested. It was indicated that vegetative waste is distinguishable from grass clippings because there are more options on disposing of grass clippings for example; residents can cut and leave their grass clippings on their lawn where that is not an option with vegetative waste.

Steven Joern, 363 Butternut Avenue, Wyckoff – Mr. Joern stated that the central issue is quality of life. Mr. Joern suggested that storms due occur and branches will fall and it is unreasonable not to have a curbside vegetative waste collection in a town such as Wyckoff. Mr. Joern suggested that the Township would have been better served by spending money on vegetative waste pick up rather than the Pulis Field artificial turf project and stated that school fields are really not used. Mr. Joern suggested that the demographics in Wyckoff are changing and a lot more senior citizens find it difficult to cart their vegetative waste or grass to the recycling center. Mr. Joern suggested grass will also need to be addressed and as a compromise solution a permit for a nominal fee for 2015 maybe an effective solution.

Barry Bloomfield, 172 Nancy Lane, Wyckoff - Mr. Bloomfield stated it was clear that the Mayor and the Township Committee were looking for a solution. Mr. Bloomfield commented that he sees the problem as a buildup of weeds and garden waste as time goes on, it is difficult for senior citizen to physically transport barrels into cars and out of cars to the recycling center and the increased number of the vehicles accessing the recycling center will also create a problem. Mr. Bloomfield suggested the Township sell barrels of a specific color for a small fee such as \$15.00 which would include a small nominal fee for the Township and the garbage company could pick up only those barrels for vegetative waste.

Kathy Oliver, 314 Paul Court, Wyckoff - Ms. Oliver suggested an online subscription where residents can request a pickup of their yard waste and the garbage carter can specifically service the home requesting curbside pickup once a week for vegetative waste.

James Savage, 448D Bromley Court, Wyckoff - Mr. Savage stated the pay for service approach for 2015 and 2016 in his opinion is the best approach. Mr. Savage also stated that he would not be in favor of switching once a week recyclable collections back to once every two weeks. Mr. Savage suggested that the change to once a week recyclable pickup works best and encourages recycling.

Richard Kuder, Superintendent of Schools, Wyckoff K-8 school district - Mr. Kuder thanked Mayor Rooney for his efforts to improve communication between the school and the Township. Mr. Kuder suggest many tangible benefits and shared services have resulted. A number of weeks ago Mr. Kuder attended an alliance meeting and the discussion focused on the “DARE” program and that it will no longer be part of the sixth grade curriculum. Mr. Kuder suggested that an opportunity exists between the school and the Township to educate the students regarding the dangers of drugs and bad decisions and is looking forward to working with the Township and continuing this positive approach.

Mayor Rooney reported that on June 24, 2015 he and Mr. Shannon attended a Wyckoff, Oakland and Franklin Lakes meeting where shared services and other similar matters that the three towns are addressing was discussed. The “DARE” program and the alcohol and drug epidemic was a major discussion point. Mayor Rooney indicated the three Mayors were in agreement that our own anti-drug programs needed to be enhanced.

WHEREAS, P.L. 2014, c. 35 enables municipalities to adopt ordinances to regulate the care, maintenance, security, and upkeep of the exterior of vacant and abandoned residential properties on which a summons and complaint in an action to foreclose has been filed;

NOW THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Wyckoff, County of

Bergen, and State of New Jersey as follows:

Section 1. Chapter 152 "Property Maintenance" of the Code of the Township of Wyckoff is hereby supplemented by the addition of the following:

Section 152-17: Vacant and Abandoned Residential Properties.

§ A. Creditor responsible.

The creditor filing the summons and complaint in an action to foreclose shall be responsible for the care, maintenance, security, and upkeep of the exterior of a vacant and abandoned residential property. If the creditor is located out-of-State, the creditor shall be responsible for appointing an in-State representative or agent to act for the foreclosing creditor. An out-of-State creditor shall include the full name and contact information of the in-State representative or agent in the notice required to be provided pursuant to N.J.S.A. 46:10B-51 for providing notice to the municipal clerk that a summons and complaint in an action to foreclose on a mortgage has been served.

§ B. Notice of violation.

The Zoning Officer is authorized to issue a notice to the creditor filing the summons and complaint in an action to foreclose, if the Zoning Officer determines that the creditor has violated this article by failing to provide for the care, maintenance, security, and upkeep of the exterior of the property. Such notice shall require the person or entity to correct the violation within 30 days of receipt of the notice, or within 10 days of receipt of the notice if the violation presents an imminent threat to public health and safety. This issuance of a notice pursuant to this section shall constitute proof that a property is "vacant and abandoned" for the purposes of N.J.S.A. 2A:50-73.

§ C. Violations and penalties.

1. An out-of-State creditor subject to the requirements of this article found to be

in violation of the requirement to appoint an in-State representative or agent pursuant to this article shall be subject to a fine of \$2,500 for each day of the violation. Any fines imposed on a creditor for the failure to appoint an in-State representative or agent shall commence on the day after the 10-day period set forth in N.J.S.A. 46:10B-51 for providing notice to the municipal clerk that a summons and complaint in an action to foreclose on a mortgage has been served.

2. A creditor subject to the requirements of this article found to be in violation of the requirement to correct a care, maintenance, security, or upkeep violation cited in a notice issued pursuant to this article shall be subject to a fine of \$1,500 for each day of the violation. Any fines imposed pursuant to this paragraph shall commence 31 days following receipt of the notice, except if the violation presents an imminent risk to public health and safety, in which case any fines shall commence 11 days following receipt of the notice.
3. No less than 20 percent of any money collected pursuant to this article shall be utilized by the Township for code enforcement purposes.
4. In addition to the violations and penalties provided in Section C, the Zoning Officer may also utilize the provisions in Section 152-12 to remove the violations and to utilize Section 152-12D to collect the cost of removal by establishing a lien upon such lands and the lien shall be added and become, in form, part of the taxes next to be assessed and levied upon such lands. Such amount shall bear interest at the same rate as taxes and shall be collected and enforced by the same officers and in the same manner as taxes.
5. The collection method for violations and penalties established in Section 152-17 shall be the collection method provided in Section 152-16.

Section 2. Repealer.

All ordinances or parts of ordinances inconsistent or in conflict with this Ordinance

Section 3. Severability.

If any section, part of any section, or clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional, such decision shall not affect the remaining provisions of this ordinance. The governing body of the Township of Wyckoff declares that it would have passed the ordinance and each section and subsection thereof, irrespective of the fact that any one or more of the subsections, sentences, clauses or phrases may be declared unconstitutional or invalid.

SECTION 1. 113-8 Residential development fees

A. Imposition of Fees

1) Within the Township of Wyckoff, all residential developers, except for developers of the types of developments specifically exempted below and developers of developments that include affordable housing, shall pay a fee of one and a half percent (1.5%) of the equalized assessed value for ~~all new~~ residential development provided no increased density is permitted. ~~Development fees shall also be imposed and collected when an additional dwelling unit is added to an existing residential structure; in such~~

SECTION 2. 113-8 Residential development fees

B. Eligible Exactions, Ineligible Exactions and Exemptions for Residential Developments

~~3) Improvements or additions to existing one and two family dwellings on individual lots shall not be required to pay a development fee, but a development fee shall be charged for any new dwelling constructed as a replacement for a previously existing dwelling on the same lot that was or will be demolished, unless the owner resided in the previous dwelling for a period of one year or more prior to obtaining a demolition permit. Where a development fee is charged for a replacement dwelling, the development fee shall be calculated on the increase in the equalized assessed value of the new structure as compared to the previous structure.~~

3) Development fees shall be imposed and collected when an existing structure undergoes a change to a more intense use, is demolished and replaced, or is expanded, if the expansion is not otherwise exempt from the development fee requirement. The development fee shall be calculated on the increase in the equalized assessed value of the improved structure.

SECTION 3. Except as hereby amended, all other sections of Chapter 113 "Fees" shall remain in full force and effect.

SECTION 4. This Ordinance shall take effect upon final passage and publication as required by law.
