#1814 – AN ORDINANCE AMENDING THE CODE OF THE TOWNSHIP OF WYCKOFF, CHAPTER 177, "VEHICLES AND TRAFFIC" ARTICLE XIII, TRAFFIC CONTROL FOR STREETS AND HIGHWAY CONSTRUCTION, SECTION 177-53 "ADOPTION OF MANUAL ON UNIFORM TRAFFIC CONTROL DEVICES FOR STREETS AND HIGHWAYS; PENALTY."

BE IT ORDAINED by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey that Section 177-53, "Adoption of Manual on Uniform Traffic Control Devices for Streets and Highways; penalty is supplemented and amended as follows:

SECTION 1 Chapter 177-53 is hereby amended and supplemented to read as follows:

<u>177-53.</u> Adoption of Manual on Uniform Traffic Control Devices for streets and highway; penalty.

The Township Committee hereby finds and declares that problems of traffic control occur when traffic must be moved through or around road or street construction, maintenance operations and utility work, above or below ground, which requires blocking the roadway and obstruction the normal flow of traffic; and that such obstructions are or can become dangerous when not properly controlled. In order to better promote the public health, safety, peace and welfare, it is necessary to establish controls and regulations directed to the safe and expeditious movement of traffic through construction and maintenance zones and to provide safety for the work forces performing theses operations. Therefore, the Township Committee does hereby adopt the current Manual on Uniform Traffic Control Devices, 2009 MUTCD with revisions 1 and 2, May 2012, hereafter known as "MUTCD," except as hereby amended and supplemented, as it controls and regulates whenever construction, maintenance operations or utility work obstructs the normal flow of traffic. Any person, contractor or utility work obstructs the normal flow of traffic. Any person contractor or utility who fails to comply with the provision of MUTCD while performing such work is in violation of this section.

A.

Preconstruction meetings <u>are required.</u> It shall be the responsibility of the person, contractor or utility, in the case of a public utility as required under the public utility agreement, Section 16:25-9.2, [1] wishing to conduct work on, under or above the roadway to contact the Traffic Bureau of the Township of Wyckoff Police Department in order to arrange a preconstruction meeting in order to submit plans for the safe movement of traffic during such period of construction

work. Any person, contractor or utility who fails to comply with this section prior to the start of such work or whose plans are not approved by the Traffic Bureau of the Township of Wyckoff Police Department is in violation of this section.

Editor's Note: The public utility agreement is on file in the Township offices.

- <u>B.</u>
 Emergency contact phone numbers. The person, contractor or utility shall provide the Traffic Bureau with at least two emergency contact phone numbers to be called in case of emergency problems at the construction or maintenance site prior to the start of any work. If for any reason emergency contacts cannot be reached or if the emergency contact person does not respond to a call from the Police Department to correct a hazardous condition, the Township may respond to correct such hazardous condition. The reasonable fees for such emergency services by the Township shall be charged to the person, contractor or utility responsible for the condition.
- Time limits. There shall be no construction, maintenance operations or utility work on any roadway in the Township before the hour of 9:00 a.m. or after 4:00 p.m. This time limit may be adjusted to permit work prior to 9:00a.m. or after 4:00p.m. by the officer in charge of the Traffic Bureau of the Township of Wyckoff Police Department. If it is determined by the officer in charge of the Traffic Bureau that the construction or maintenance operation prior to 9:00 a.m. or after 4:00 p. m. would substantially delay traffic or cause a safety or health hazard, the work shall then be permitted only between 9:00 a.m. and 4:00 p.m.
- <u>D.</u>
 Road closing and detours. Road closings and/or traffic detours shall not be permitted unless approved by the Township of Wyckoff Police Traffic Bureau.

Road closing and detours: Road and/or lane closures and traffic detours shall not be permitted unless approved by the Wyckoff Police Department Traffic Safety Bureau. It shall be the responsibility of the person, contractor or utility to provide a detailed outline of the proposed road and/or lane closure and traffic detour prior to any work beginning. This must approved by Wyckoff Police Traffic Bureau (or his /her designee).

E. Traffic control officers. Traffic control officers shall be posted at all construction sites when determined by the Township of Wyckoff Police Traffic Bureau that the same is necessary to provide for the safety and expeditious movement of traffic.

Traffic control officers: For the purpose of this article, a traffic control officer is that individual who is responsible for traffic control at a roadway work/maintenance site and is a Township of Wyckoff Police Officer.

- 1. Traffic control officers and police emergency vehicles shall be posted at all roadway/maintenance work sites when determined by the Wyckoff Police Traffic Safety Bureau that the same is necessary to provide for the safety and expeditious movement of traffic.
- 2. Civilian flaggers shall not be used unless the Township of Wyckoff
 Police Department cannot provide traffic control officers with an
 emergency vehicle or approved by the Wyckoff Police Traffic Safety
 Bureau. Civilian Flaggers shall not be used a traffic control officers in any
 work/maintenance zone, which contains an intersection with traffic control
 device, or cause an impact/delay, which creates unsafe travel at any
 intersection with in the Township of Wyckoff. In those cases a traffic
 control officer must be used.

3. Civilian flaggers must meet qualification set forth in Section 6E of the MUTCD and is a certified flagger by Rutgers University or comparable organization. Civilian flaggers must be in possession of their certification when working in any work/maintenance zone and be able to present them upon request. These assignment shall be approved by the Chief of Police, Wyckoff Police Traffic Safety Bureau (or his/her designee)

<u>F.</u>
Stop work. The Traffic Bureau of the Township of Wyckoff Police Department shall have the authority to stop work, including the removal of equipment and vehicles and stored material within the street right-of-way, backfilling of open excavations and/or other related work, in order to abate any nuisance and/or safety hazard or for any violation of this section.

Stop Work: The Traffic Safety Bureau and Township of Wyckoff Police Officers

Stop Work: The Traffic Safety Bureau and Township of Wyckoff Police Officers shall have the authority to stop all work, including the removal of equipment and vehicle and stored material within the work/maintenance zone (street right of way) backfilling of open excavations and/or other related work, in order to abate any nuisance and/or safety hazard or for any violation this section.

<u>3.</u>

Violations and penalties.

(1)

Any person, contractor or utility who commits a violation of this article shall, upon conviction thereof for a first offense, pay a fine of not less than \$100 nor more than \$500 and/or be imprisoned in the County Jail for a term not exceeding 90 days; for a second offense, upon conviction thereof, pay a fine of not less than \$250 and/or be imprisoned in the County Jail for a term not exceeding 90 days; for a third or subsequent conviction, pay a fine or not less than \$500 and/or be imprisoned in the County Jail for a term not exceeding 90 days.

A separate offense shall be deemed committed on each day during or on which a violation occurs or continues.

<u>SECTION 2</u>- Except as herein amended and supplemented, all other provision of Chapter 177 of the Code of the Township of Wyckoff, Vehicles and Traffic, shall remain in full force and effect.

SECTION 3 – This ordinance shall take effect immediately upon final passage and publication as required by law.

Wyckoff Mayor Kevin J. Rooney Swears-In New Police Chief

Tonight, Mayor Kevin J. Rooney officially swore-in Acting Chief David Murphy as the Wyckoff Chief of Police.

"Acting Chief of Police David Murphy will continue to serve as Wyckoff's top law enforcement officer and I am extremely proud to remove the word 'Acting' from his title," said Wyckoff Township Mayor Kevin J. Rooney. "Chief of Police Murphy has earned this position and the confidence of the residents of Wyckoff, by his dedication and commitment to improve our police department and keep all of our residents safe."

The new Chief of Police has 21 years of law enforcement experience. Of those 21 years, he has spent the last 10 in a police leadership position.

He is a highly trained and decorated officer and has received the END DWI Award twice, an Assembly Commendation regarding the END DWI initiative, numerous Letters of Merit for his work as a law enforcement officer, and two Written Commendations regarding his response to armed robberies of a jewelry store in 2001 and 2011.

During his career, Chief Murphy has received the 9-11 Dana Hannon Distinguished Service Award and served our township as a volunteer firefighter for 25 years including Wyckoff Fire Department Chief for four years.

Mayor Rooney concluded, "The citizens of Wyckoff will be proud of their police force under steady leadership and professionalism demonstrated by Chief Murphy. Making David Murphy the permanent Chief of Police was an easy decision for me to make as Mayor and the rest of the township committee."

Recognition of Officer Terrence Murphy and the efforts of the Wyckoff Police Department and the Wyckoff Volunteer Ambulance Corps.

Wyckoff Mayor Kevin J. Rooney Recognizes Heroic Police Officer

Tonight, Mayor Kevin J. Rooney honored Police Officer Terrence Murphy for going above and beyond the call of duty by saving the life of a young Wyckoff resident

Mayor Rooney stated, "Officer Terrence Murphy personified his oath by saving the life of a young man with a serious injury. His actions demonstrate the very best of law enforcement officers and their respect for the residents they serve. We are fortunate to have Officer Terrence Murphy on the force protecting the well-being of our fellow residents, business owners and visitors."

The Mayor recognized the courageous actions of Officer Terrence Murphy. On August 22, 2016, Officer Murphy and Officer Kevin Pinches responded to a call for medical assistance. Officer Murphy immediately recognized that this was not going to be an ordinary call for assistance. Officer Murphy found that the young man severely injured himself by putting his arm through an old glass plate window of a side door to a garage. The teen had struck an artery and was losing a large amount of blood. Due to the training he had received, Officer Murphy recognized that he had only a few minutes to act. After assessing the trauma, Officer Murphy took action immediately.

Remembering that Officer William Plisich had stocked a "Quik-Clot" bandage (primarily used for bullet wounds) in his medical bag, Officer Murphy put the lifesaving tool to work and affixed it to the wound while applying direct pressure. Officer Murphy was able to control and stop the active bleeding. In the meantime, Wyckoff Volunteer Ambulance Corps members Hayley Rooney and Jen Martin arrived on scene and took over the young man's care.

Both Wyckoff police officers traveled to the hospital with the injured teen. Once at the hospital, the teen was immediately brought into surgery. If not for the actions of Officer Murphy, the outcome of this incident would have been gravely different.

At the conclusion of the presentation, Mayor Rooney added, "As Mayor and Police Commissioner, I feel that it is my responsibility to recognize members of our police department that go above and beyond the call of duty or in the case of Officer Murphy, whom take quick and decisive action which ultimately saves a life. The fine work of the officers and first responders involved demonstrates the devotion and esteem these civil servants have for our community. The entire township committee shares in honoring Officer Terrence Murphy for his heroic actions."
