In years 2010 & 2011 this amount shall not exceed \$21.00 per pay and in 2012 through 2016 shall not exceed \$30.00 per pay.

There shall be no limit as to the number of consecutive terms served by an alternate member.

ORDINANCE #1757

AN ORDINANCE TO PROVIDE A CERTAIN CAPITAL IMPROVEMENT IN THE TOWNSHIP OF WYCKOFF AND TO PROVIDE FOR THE RECEIPT, ACCEPTANCE AND DEPOSIT OF DONATED FUNDS AND MATERIALS FOR THE CONSTRUCTION OF OUTDOOR SPORTS LIGHTING FOUNDATIONS AT BLOCK 202, LOT 7.03.

WHEREAS, the Wyckoff Family YMCA is improving the Pulis soccer field area and parking lot located on Block 202, Lot 7.03 with two artificial turf sport playing surfaces; and

WHEREAS, the Township of Wyckoff plans at a future time to install outdoor sports lighting for the improved Pulis Field; and

WHEREAS, certain improvements are required to be constructed before the construction of the artificial turf sport playing surface to allow a future decision to install outdoor sports lighting; and

WHEREAS, the Wyckoff Parks and Recreation Foundation has advised the Township it wishes to gift to the Township materials and donate funds of \$27,624.00 for the construction of structural concrete foundations at the Pulis Soccer Field facility on Block 202, Lot 7.03 to support and anchor the future construction of outdoor sports lighting poles and overhead lighting fixtures.

NOW THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Wyckoff, County of Bergen, as follows:

The Township of Wyckoff, in the County of Bergen shall proceed with the acceptance of materials and construction of structural concrete foundations at the Pulis Soccer Field facility on Block 202, Lot 7.03 with materials and \$27,624.00 of funding donated by the Wyckoff Parks & Recreation Foundation.

SECTION 2. The cost of implementing said improvements in Section 1 shall be paid by the Township out of funds to be received specifically for said purpose from the Wyckoff Parks and Recreation Foundation.

SECTION 3. It is hereby determined and stated:

- a. Said purpose is not a current expense. The same is an Improvement which the Township of Wyckoff may lawfully make or acquire and no part of the cost of said improvement has been or shall be specifically benefitted.
- b. It is not necessary to finance this authorization by the issuance of obligations by the Township of Wyckoff pursuant to the Local Bond Law of the State of New Jersey.
- c. The total authorized appropriation in the ordinance is \$27,624.00 from donated funds.

SECTION 4. The monies which the Township of Wyckoff is authorized to receive pursuant to the donation from the Wyckoff Parks and Recreation Foundation shall, when received, be placed in Dedication by Rider: Pulis Field Improvements, pursuant to Township of Wyckoff Resolution 14-117; Dedication by Rider Improvement of Pulis Field required by NJSA 40A:5-29 of the Township of Wyckoff for the purpose set forth in Section 1 of this ordinance.

SECTION 5. It is hereby determined and stated that no supplemental debt statement is required to be made and signed in connection with said purpose, since the gross debt of the Township of Wyckoff as defined under the Local Bond Law is not increased by this Ordinance, and no obligations in the matter of notes or bonds are authorized by the Ordinance.

SECTION 6. This ordinance shall take effect after publication thereof and final passage as required by law.
