Mayor Douglas J. Christie called the regular meeting of the Wyckoff Township Committee in the Municipal Court Room to order at 8:00 pm.

The Township Committee proceeded with the Pledge of Allegiance led by Boy Scout Alex Ward.

The Invocation was given by Pastor Rich Higby from Cornerstone Church.

Open Public Meeting Act Statement

Municipal Clerk Santimauro read the "Open Public Meeting Act" Statement: "This regular meeting of the Township Committee of the Township of Wyckoff is now in session. In accordance with the provisions of Section 8 of the Open Public Meetings Act, I wish to advise that notice of this meeting has been posted in the lower level of the Memorial Town Hall and that a copy of the schedule of meetings has also been filed with the Township Clerk, and copies of this agenda and the annual notice of meetings, of which this is a part, have been heretofore sent to the Ridgewood News, The Record, and The North Jersey Herald and News all papers with general circulation throughout the Township of Wyckoff. At least 48 hours prior to this meeting the Agenda thereof was similarly posted, filed and mailed to said newspapers."

Meeting Open for Public Comment

The Township Committee voted unanimously to open the public portion of the meeting.

Mrs. Susan Winton, 80 Logan Lane. Mrs. Winton advised the Township Committee that the Environmental Commission is showing four (4) movies at the Wyckoff Library with one (1) point of view. The movie "Groundswell" was shown, which is an anti-fracking movie, the Environmental Commission is showing one side of an issue and they should portrait both sides of an issue when using the public library.

Deputy Mayor Kevin Rooney reported that tonight he has the pleasure of announcing, after three (3) years of hard work, that the public private partnership proposal for constructing an artificial turf field for the children of Wyckoff at the Pulis Recreation Facility will be a reality. This is due to the hard work and efforts of many folks including members of the Wyckoff Parks and Recreation Foundation (Chris Vanouga, Dave Buchanan, Laura Morris and Tom Madigan), the Torpedoes Soccer Club, the Wyckoff Family YMCA who expressed an interest to be part of the process and stepped up in a big way to be a donor. Also present and who worked positively and cooperatively with the public private partnership were the members of the Spring Meadow Condominium Association, who are also here tonight.

The purpose of the improvement is to make safe playing fields. A walking trail around the soccer field component will be included for use by the Spring Meadow Condominium Association members as well as the public.

Mayor Doug Christie recognized Deputy Mayor Kevin Rooney for moving this project forward and being a positive member of the committee for the past four (4) years.

Deputy Mayor Kevin Rooney indicated that this journey started in February 2010 with a lot of discussions and differences all bringing this public private partnership together and making it a reality. There still are not enough funds to finish everything – the Wyckoff Family YMCA and the Wyckoff Park and Recreation Foundation will continue to do further fund raising. The Wyckoff Parks and Recreation Foundation has a golf outing fund raiser scheduled for May 13, 2014 and the Wyckoff Family YMCA has a dinner fund raiser scheduled for June 4, 2014 to raise addition funds for the benefit of our children.

The Pulis Recreation Facility will include a planted berm at the end row of units at the Spring Meadow Condominiums, two (2) artificial turf fields, a gravel parking lot, an interior road way with access to Charles Avenue over the rail road crossing and connecting to the YMCA parking lot. Underground stanchions for the future installation of energy efficient outdoor sports lighting and the future construction of bathroom facilities. This process has included a lot of hard work and the hard work continues with construction starting in August. This entire project will have a zero impact on our tax payers.

Deputy Finance Chairman Brian Scanlan expressed his gratitude to all parties for their hard work on the redevelopment of the Pulis Soccer Field. The drainage improvements especially when it rains will be a welcome improvement by alleviating the ponding of water that has been occurring.

Committeeman Rudy Boonstra echoed the comments made by Deputy Mayor Rooney and Committeeman Scanlan and thanked the Wyckoff Parks and Recreation Foundation for conceiving the project; he gave a special thanks to the Wyckoff Family YMCA who stepped up to the plate and for taking on the imlementation of the project. He also praised Deputy Mayor Rooney as the one person most consistent and constant over the past four (4) years for making this project a reality.

Committeeman Haakon Jepsen expressed his gratitude and excitement for this project.

Mayor Christie thanked the members of this public private partnership for their hard work and perseverance as well as Township Attorney Robert Landel who makes sure everything is legal.

Mr. Vanouga thanked the Township Committee, especially Deputy Mayor Rooney, Township Attorney Rob Landel, Department of Public Works Manager Scott Fisher; Mr. Jim Finn and Mr. Roy Jones of the Torpedoes Soccer Club; Joy Vottero, Joyce Kwiatkowski, Kevin Cornwall and Frank Crotty from the Wyckoff Family YMCA; and Spring Meadow Condominium Association President Mrs. Kathleen Smith.

Mr. Vanouga is very happy and excited that the improvement will move forward. He also thanked the Wyckoff Recreation Board for their guidance, Wyckoff merchants for their sponsorship, Jonathan Cantor and the Market Basket, Howie Felixbrod for planning the golf outing fund raiser, Laura Morris and Tom Madigan of the foundation and especially the 1,000 families in Wyckoff who have supported the fund raising events to make this possible.

ORDINANCE #1733

**AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET
APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK**

WHEREAS, the Local Government Cap Law, N.J.S. 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to .5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Committee of the Township of Wyckoff in the County of Bergen find it advisable and necessary to increase its CY 2014 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Committee hereby determines that a 3.0% increase in the budget for said year, amounting to \$394,028.00 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Wyckoff in the County of Bergen authorized membership of this governing body affirmatively concurring that, in the CY 2014 budget year, the final appropriations of the Township of Wyckoff shall, in accordance with this ordinance and N.J.S. A. 40A:4-45, be increased by 3.0% amounting to \$394,028.00 and that the CY 2014 municipal budget for the Township of Wyckoff be approved and adopted in accordance with the ordinance; and

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Direction within 5 days after such adoption.

Mayor opens the 2014 Municipal Budget public comment portion of the meeting.

Mayor Christie thanked the Finance Committee Chairman, Committeeman Rooney, and Deputy Finance Committee Deputy Chairman, Brian Scanlan, Chief Financial Officer Diana McLeod and Township Administrator Robert Shannon for their work developing the budget and requested Deputy Mayor/Finance Committee Chairman Kevin Rooney to please provide some remarks.

Deputy Mayor Rooney reported that the 2014 municipal budget was introduced on March 21, 2014 with a lengthy discussion on changes, services and improvements in 2014. The 2014 budget totals \$17,000,000. and is slightly increased by less than 1%. Due to the difficult weather this winter season and its effect on our roads the Township Committed determined to budget \$1,300,000. for road resurfacing in 2014. The township in an effort to stretch its road resurfacing budget performed strategic bidding and was able to obtain a lower price than the regional cooperative pricing group, which will allow us to further stretch our resurfacing dollars to pave as many roads as possible.

Committeeman Jepson commented that regarding the bid process for the road resurfacing, the public should be aware of the precise bidding strategy used and that the bid process was not performed by rote. He was impressed with this team effort.

Deputy Finance Committee Chairman Brian Scanlan echoed Committeeman Rooney's comments and indicated the township's relative level of debt for 2014 is essentially the same as 2013. He described the budget as making a significant investment in the infrastructure of the township. These investments also include a sinking fund for a new roof on Town Hall sinking funds for the future purchase of fire trucks which are all conservative and prudent practices to protect the tax payers in the future from budget shock.

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WYCKOFF, IN THE COUNTY OF BERGEN, NEW JERSEY, THAT:

SECTION 1. There is hereby authorized, pursuant to the applicable statutes of the State of New Jersey, the improvements set forth below in, by and for the Township of Wyckoff, County of Bergen, State of New Jersey (the "Township"), together with other purposes necessary, appurtenant or incidental thereto or thereof:

SECTION 2. It is hereby determined and declared by this Township Committee as follows:

A. The estimated aggregate maximum amount of money to be raised from all sources for the purposes stated in Section 1 is \$1,704,400.00.

B. The estimated aggregate maximum amount of bonds or notes to be issued for the purposes stated in Section 1 is \$1,618,000.00.

C. An appropriation was or is contained in a budget or budgets of the Township heretofore adopted in the sum of \$86,400 for the purposes stated in Section 1; there is now available in said appropriation said sum of \$86,400, which sum is hereby appropriated as a down payment for the purposes stated in Section 1.

SECTION 3. The sum of \$1,704,400.00, including said down payment of \$86,400, is hereby appropriated for the purposes stated in Section 1.

SECTION 4. For the purpose of financing part of the cost of the improvements described in Section 1, exclusive of said down payment, the issuance of bonds of said Township in an aggregate principal amount not exceeding One Million Six Hundred Eighteen Thousand Dollars (\$1,618,000) is hereby authorized pursuant to the provisions of the Local Bond Law, N.J.S.A. 40A:2-1 et seq. The rate or rates of interest, maturities, method of sale and other details of said bonds not determined herein shall be determined by subsequent resolution or resolutions adopted by the Township Committee pursuant to law.

SECTION 5. Pending the issuance of the bonds authorized in Section 4 hereof, bond anticipation notes of the Township may be issued pursuant to said Local Bond Law in an aggregate principal amount not exceeding One Million Six Hundred Eighteen Thousand Dollars (\$1,618,000). Each such bond anticipation note shall be designated "Bond Anticipation Note." All bond anticipation notes issued hereunder shall mature at such times as may be determined by the Chief Financial Officer of the Township; provided that no note shall mature later than one year from its date. All such bond anticipation notes may be executed in the name of the Township by the manual or facsimile signatures of the Mayor and Chief Financial Officer or such other official of the Township as may hereafter be designated by resolution or otherwise as provided by law and shall be under

the seal of the Township and attested by the Township Clerk. The notes shall bear interest at such rate or rates and shall be in such form as may be determined by the Chief Financial Officer. The Chief Financial Officer shall determine all matters in connection with notes issued pursuant to this ordinance, and the Chief Financial Officer's signature upon the notes shall be conclusive evidence as to all such determinations. All notes issued hereunder may be renewed from time to time subject to the provisions of N.J.S.A. 40A:2-8.1. The Chief Financial Officer is hereby authorized to sell part or all of the notes from time to time at public or private sale and to deliver such notes to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest, if any, from their dates to the date of delivery thereof. The Chief Financial Officer is directed to report in writing to the Township Committee at the meeting next succeeding the date when any sale or delivery of notes pursuant to this ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the notes sold, the price obtained and the name of the purchaser or purchasers thereof.

SECTION 6. It is hereby further determined and declared by this Township Committee as follows:

A. The improvements or purposes described in Section 1 are not current expenses; they are improvements or purposes that the Township may lawfully undertake as general improvements, and no part of the cost thereof has been or shall be specially assessed on property specially benefited thereby.

B. The weighted average period of usefulness for the purposes described in Section 1 for which the bonds are hereby authorized to be issued, within the limits prescribed by the Local Bond Law, is 10.49 years.

C. All bonds or notes issued pursuant to this ordinance shall bear interest at a rate not to exceed the maximum rate permitted by law.

D. The supplemental debt statement required by said Local Bond Law has been duly made and filed in the office of the Township Clerk prior to the passage of this ordinance on first reading, and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey prior to the passage of this ordinance on final reading, and such statement shows that the gross debt of said Township, as defined in N.J.S.A. 40A:2-43, is increased by this ordinance by \$1,618,000 and that the issuance of the obligations authorized by this ordinance will be within all debt limitations contained in the Local Bond Law.

E. The aggregate amount of the proceeds of the obligations authorized by this ordinance to be expended for interest on the obligations authorized herein, engineering and inspection costs, legal expenses, and the costs of issuance of the obligations authorized by this ordinance, including printing, advertisement of ordinances and notices of sale and legal expenses, and other expenses as provided in N.J.S.A. 40A:2-20 does not exceed \$0.

SECTION 7. The capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith, and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services are on file with the Township Clerk and are available for public inspection.

SECTION 8. In the event that any other moneys are lawfully received from any source for the purposes provided in this ordinance, such moneys

shall be used for the purposes authorized herein and to reduce the amount of bonds or notes authorized to be issued by this ordinance by the amount so received, or if such other moneys are received after the issuance of the bonds or notes authorized by this ordinance, such moneys shall be used solely for the payment of the debt service on said bonds or notes as the same become due and payable.

SECTION 9. The full faith and credit of the Township is hereby pledged for the payment of the principal of and interest on all bonds and notes issued pursuant to this ordinance, and as long as such bonds or notes are outstanding there shall be levied in each year *ad valorem* taxes on all taxable property within said Township, without limitation as to rate or amount, sufficient to pay the principal of and interest on such bonds and notes maturing in said year.

SECTION 10. (a) The Township shall comply with all provisions of the Internal Revenue Code of 1986, as amended, and the regulations promulgated thereunder or applicable thereto (the "Code") applicable to the bonds or notes issued pursuant to this bond ordinance and shall not take any action, or fail to take any action, if any such action or failure to take action would cause interest on the bonds or notes issued pursuant to this bond ordinance to be or become includable in gross income under Section 103 of the Code or cause interest on the bonds or notes issued pursuant to this bond ordinance to be treated as an item of tax preference under Section 57 of the Code. The Township shall not directly or indirectly use or permit the use of any proceeds of such obligations or any other funds of the Township, or take or omit to take any action, that would cause such obligations to be "arbitrage bonds" within the meaning of Section 148(a) of the Code, and will comply with all requirements of Section 148 of the Code to the extent applicable to the bonds and notes authorized hereby and all proceeds thereof, including without limitation, monitoring compliance with Section 148 of the Code as it applies to the bonds and notes authorized hereby, restricting the yield on the investment of any proceeds or gross proceeds of the bonds or notes to the extent required to comply with Section 148 of the Code, and making payments of the rebate amount, if any, to the United States in the manner and to the extent necessary to comply with Section 148 of the Code.

(b) The Township reasonably expects to reimburse the Township's expenditure of certain costs of the improvements or purposes described in Section 1 of this bond ordinance ("Project Costs") incurred and paid prior to the issuance of any bonds or notes authorized by this bond ordinance with the proceeds of such bonds or notes. This Section is intended to be and hereby is a declaration of the Township's official intent to reimburse any expenditure of Project Costs incurred and paid prior to the issuance of bonds or notes authorized herein with the proceeds of such bonds or notes in accordance with Treasury Regulations Section 1.150-2(e), and no reimbursement allocation will employ an abusive arbitrage device under Treasury Regulations Section 1.148-10 to avoid the arbitrage restrictions. The maximum principal amount of obligations expected to be issued pursuant to this bond ordinance to pay Project Costs does not exceed \$1,618,000. The Project Costs to be reimbursed with the proceeds of the bonds or notes authorized herein will be "capital expenditures" as defined in Treasury Regulations Section 1.150-1(b), a cost of issuance for the bonds or notes herein authorized or an expenditure described in Treasury Regulations Section 1.148-6(d)(3)(ii)(B). The allocation of proceeds of the bonds or notes issued pursuant to this bond ordinance to reimburse Project Costs incurred prior to the issuance of such bonds or notes shall

#14-149 Authorize Contract to Pave Roads

WHEREAS, Ordinance #1100 authorized participation in a cooperative pricing system with municipalities in Northwest Bergen County; and,

WHEREAS, the Township of Wyckoff is a current member of the Northwest Bergen Cooperative Pricing System; and,

WHEREAS, the Township of Wyckoff suffered a very severe winter which fell 73.5 inches of snow and required the DPW to respond to seventeen (17) snow/ice emergencies; and,

WHEREAS, this winter's fluctuating temperatures between freezing and warm with rain and ice deteriorated many of Wyckoff's asphalt roads; and,

WHEREAS, the Township Committee of the Township of Wyckoff determined that the responsible course of action would be to increase the Township's road resurfacing appropriation to counter the negative effects that resulted to Wyckoff roads due to this winter's weather; and,

WHEREAS, funds are not unlimited and the Township cannot pave every road, requiring difficult choices among valid requests; and,

WHEREAS, consistent with past practices, the Township Committee relies on the professional opinion of the Township Engineer, Public Works Manager and Chief of Police to determine the roads most in need of repair; and,

WHEREAS, the Township Committee desires to pave the most roads in need of repair and therefore authorized bidding through the Northwest Bergen Cooperative Pricing System aggregating the volume of work with many other municipalities to obtain discount volume pricing and on 4/1/14 authorized a separate Wyckoff procurement for road resurfacing in accordance with N.J.S.A. 5:34-7.20 providing the Township of Wyckoff with the flexibility of two (2) advertised competitive bidding opportunities to obtain the most competitive price for our taxpayers; and,

WHEREAS, a public notice soliciting bids for the Township of Wyckoff's procurement was advertised on 3/28/14 in the Ridgewood News and posted on the Township's website under the easily accessed quick link on the homepage titled, Bids and Jobs; and,

WHEREAS, fourteen (14) potential bidders obtained copies of the bid specifications free of charge to encourage bidding; and,

WHEREAS, on 4/17/14 at 11:00 a.m. the Township received eight (8) sealed bids which were opened and their contents read aloud as reflected in the attached minutes of the bid opening prepared by the Municipal Clerk; and,

WHEREAS, the Borough of Ramsey (the lead agency for the Northwest Bergen Cooperative Pricing System) has complied with the Local Public Contracts Law and publicly advertised, received, opened and read the bids as indicated on the attached summary sheet; and,

WHEREAS, the unit price per ton of asphalt from the regional Northwest Bergen Cooperative Pricing Competitive low bidder is \$71.80 per ton installed; and,

WHEREAS, the unit price per ton of asphalt from the Township of Wyckoff cooperative bid is \$69.21 per ton installed; and,

WHEREAS, the significance of this strategic procurement result is an additional \$37,000 available for road resurfacing due to the favorable competitive unit price; and,

WHEREAS, the Township of Wyckoff shall advise the Cooperative Pricing System that it shall withdraw its estimate from the Cooperative Pricing bid because the Township captured a lower unit price through the Wyckoff advertised competitive procurement; and,

WHEREAS, the Chief Financial Officer has issued a certificate attached to this resolution which indicates that available funds are subject to the adoption of 2014 Capital Ordinance #1740.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey that they do hereby authorize a contract to the lowest responsive and responsible bidder, D & L Paving Contractors, Inc., 681 Franklin Avenue, Nutley, New jersey 07110 at a rate of \$69.21 per ton of installed asphalt and milling at \$2.49 a square yard at an estimated not to exceed contract amount up to \$1,185,798.11.

BE IT FURTHER RESOLVED, that the Public Works Manager is authorized to begin the preparations for road resurfacing and the road resurfacing shall not begin until 5/23/14 which is the expiration of the adoption notice period for Capital Ordinance #1740.
