#14-98 Establish Lien – 632 Lawlins Road for Failure to Maintain Property

WHEREAS, the residential home and land at 632 Lawlins Road, Block 230/Lot 22 is owned by Alexander and Edward Markisz; and,

WHEREAS, the Township Committee of the Township of Wyckoff has established a property maintenance code known as Chapter 152 of the Code of the Township of Wyckoff; and,

WHEREAS, all owners of property in the Township of Wyckoff are required to comply with the provisions in Chapter 152 of the Code of the Township of Wyckoff; and,

WHEREAS, adjacent property owners and neighbors have brought property maintenance violations to the attention of the Zoning Administrator and the Zoning Administrator has issued an abatement notice in compliance with Chapter 152 to the owner and mortgagee of 632 Lawlins Road. The Zoning Administrator has attempted to obtain compliance through letters, telephone calls and e-mails as detailed on the attached certification with the result that the owner and mortgagee have failed to abate the violations enumerated in the abatement notice; and,

WHEREAS, property owner has the duty to remove the violations after notice has been issued; and,

WHEREAS, the Zoning Administrator has filed a certification dated January 17, 2014 (attached as if set forth at length) in compliance with Chapter 152 which certifies the cost of \$1,150.00 as the verified charge to abate certain violations; and,

WHEREAS, the attached certificate with attachments is presented to the Township Committee for their examination and if found correct, to be charged against the lands upon which the violation existed.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey that they have examined the certification dated January 17, 2014 from the Zoning Administrator and find it to be correct and cause the cost of \$1,150.00 to be charged against the land, namely Block 230/Lot 22, known as 632 Lawlins Road as a lien on the property for the cost to abate the property maintenance violation.

BE IT FURTHER RESOLVED, that the amount of \$1,150.00 charged shall become a lien upon such lands and shall be added to and become, in form, part of the taxes next to be assessed and levied upon Block 230 Lot 22, 632 Lawlins Road. This amount shall bear interest at the same rate as taxes and shall be collected and enforced by the Tax Collector and in the same manner as taxes.

BE IT FURTHER RESOLVED, that the Municipal Clerk shall provide a certified copy of this resolution and certification to the property owner, the Wyckoff Tax Collector, and the Zoning Administrator.

#14-99 Urge the State Legislature to Make permanent the 2% Cap on Interest Arbitration Police Salary Award to Help Limit the Largest Cost Driver in Municipal Budgets

WHEREAS, on December 21, 2010 Governor Christie signed into law reforms to the Arbitration process that took effect January 1, 2011; and,

WHEREAS, the reforms capped arbitration awards on economic factors to no more than 2% provided for random selection of arbitrators, expedited the determination of awards, required the arbitrator to provide a written report detailing the weight accorded to each of the required considerations and expedited the appeal process; and,

WHEREAS, these reforms marked a dramatic change to the arbitration process and have helped municipalities to control the never-ending rise in public safety personnel costs; and,

WHEREAS, a key element of the reforms, capping arbitration awards on economic factors to no more than 2% of the property tax levy will expire on April 1, 2014; and,

WHEREAS, while municipalities are statutorily limited to raise their property tax levy by no more than 2%, with very limited exceptions, failure to extend the 2% cap in interest arbitration awards will force municipalities throughout the State to further reduce or even eliminate crucial services, personnel and long-overdue infrastructure improvement projects in order to fund an arbitration award; and,

WHEREAS, the 2% Interest Arbitration cap has controlled one of the largest municipal expenses, public safety salaries, not only through arbitration awards but through contract negotiations; and,

WHEREAS, absent further action by the Legislature, any contract that expires on or after April 1, 2014, will be subject to all new procedures and requirements, EXCEPT the 2% awards cap; and,

WHEREAS, without those limits, arbitrators will be able to impose awards that do not account for the 2% limit on the property tax levy, which would immediately threaten funding for all other municipal services; and,

WHEREAS, without the 2% cap on Interest Arbitration Awards but with the 2% cap on property tax levy local budget makers could be forced to reduce other essential municipal services to fund an arbitration award.

NOW THEREFORE BE IT RESOLVED, that the governing body of the Township of Wyckoff **STRONGLY URGES THE LEGISLATURE TO PERMANENTLY EXTEND THE 2% CAP ON INTEREST ARBITRATION AWARDS PRIOR TO THE APRIL 1, 2014 SUNSET.**

BE IT FURTHER RESOLVED, that a copy of this duly adopted resolution be forwarded to Senate President Stephen Sweeney, Assembly Speaker Vincent Prieto, the Legislators of the 40th Legislative District, State Legislative representatives, Governor Chris Christie and the New Jersey State League of Municipalities.

WHEREAS, the Township Committee of the Township of Wyckoff has determined that an issue exists with regard to the overbuilding of residential properties within the Township of Wyckoff, to the extent that residents have difficulty maneuvering their vehicles into side yard facing garages; and

WHEREAS, the Township Committee of the Township of Wyckoff recognizes that the Zoning Ordinance requires residential houses to have garages; and

WHEREAS, the Township Committee of the Township of Wyckoff recognizes that the size of homes have increased over the years to the extent that the existing minimum side yard setback requirements are not sufficient to provide adequate buffers for such larger homes; and

WHEREAS, the Township Committee of the Township of Wyckoff wishes to maintain open space, appropriate buffers in between homes and the character and aesthetic beauty of the Township of Wyckoff; and

WHEREAS, the Township Committee of the Township of Wyckoff believes that an Enhanced Side Yard Setback Ordinance will provide for sufficient space to allow for the proper functionality of side yard facing garages and will provide for sufficient buffers in between homes by providing for larger side yard setbacks as larger homes reach specific sizes and thereby preserving open space; and

WHEREAS, the Township Committee of the Township of Wyckoff is authorized to pass this Ordinance;

BE IT ORDAINED, by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey, Chapter 186 (Zoning), is hereby amended to create new Article XII, Enhanced Side Yard Setbacks, as follows:

SECTION 1 - Article XII. Enhanced Side Yard Setbacks

Chapter 186-65- Definitions.

GROSS BUILDING AREA – is defined as the gross building floor area of the buildings on the property. The gross building area shall include all enclosed floor areas on all floors for residences, accessory buildings and garages. The gross building area shall not include open porches, unfinished attics, basements, decks or patios.

SIDE YARD SETBACK – the minimum dimension between a building or structure and the side property line.

- A. In the RA-25 and RA-15 Zones, garages which face the side yard shall be no less than 27 feet from the side yard property line.
- B. In the RA-15 Zone, if a home has a gross building area which exceeds 2,700 square feet, the minimum side yard setback shall be 20 feet.
- C. In the RA-25 Zone, if a home has a gross building area which exceeds 3,700 square feet, the minimum side yard setback shall be 25 feet.

This Ordinance shall take effect upon final passage and publication as required by law.

SECTION 1 - Chapter 152, Property Maintenance, Section 152-11, Prohibited Matter, Materials and Conditions, is amended to include new subparagraph "A.

Notwithstanding this paragraph, the Township shall also continue to have all rights and remedies provided in Chapter 165 of the Code of the Township of Wyckoff and all sidewalk replacements, repairs and/or reconstruction pursuant to this section must be made consistent with the requirements and specifications contained in Chapter 165.

SECTION 2 - Except as hereby amended, all other Sections of Chapter 152 shall remain in full force and effect.
