Open Public Meeting Act Statement

Municipal Clerk Santimauro read the “Open Public Meeting Act” Statement: “This regular meeting of the Township Committee of the Township of Wyckoff is now in session. **#17-126      Alcohol Awareness Month**

**WHEREAS**, alcohol is a primary factor in the four leading causes of death for young person's ages 10-21; and,

**WHEREAS**, almost 100,000 persons die each year from alcohol-related causes: drinking and driving crashes, other accidents, falls, fires, alcohol-related homicides and suicide; and,

**WHEREAS**, approximately 15 million current drinkers in the United States are dependent on alcohol; and,

**WHEREAS**, adolescents use alcohol more than tobacco or illicit drugs; and,

**WHEREAS**, young people begin drinking, on average, at 13.1 years of age; and,

**WHEREAS**, young people who begin drinking before age 15 are four times more likely to develop alcohol dependence than those who begin drinking at age 21; and,

**WHEREAS**, alcohol is involved in fifty percent of criminal assault, traffic, theft, fraud, vandalism and sex crime cases in the juvenile justice system. Older friends and siblings are the primary source by which underage youth obtain alcohol. Providing alcohol to minors is against the law, and that together we should work to keep it out of their hands; and,

**WHEREAS**, it is imperative that we join with others in advancing efforts to strengthen the enforcement of our underage drinking laws, and build partnerships among local agencies, elected officials, law enforcement, businesses, schools, and communities to prevent underage drinking and alcoholism.

**NOW, THEREFORE BE IT RESOLVED**, by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey that we, the Wyckoff Township Committee join the National Council on Alcoholism and Drug Dependence, Inc, (NCADD) and The New Jersey Division of Alcohol Beverage Control and do hereby proclaim that April 2017 is Alcohol Awareness Month in Wyckoff, New Jersey.

**#17-129      Resolution Supporting A-4234**

**WHEREAS**, almost all local units of government and Boards of Education in New Jersey secure insurance through governmental entities known as joint insurance funds (hereinafter JIFs): and,

**WHEREAS**, existing law limits JIFs to investments otherwise authorized for local governmental entities and Boards of Education; and,

**WHEREAS**, existing law greatly limits the potential investment earnings, currently less than 1% on investments of approximately \$1 billion; and,

**WHEREAS**, S-2663 and A-4234 would permit JIFs to invest in debt obligations of any governmental entity established under the laws of the State of New Jersey; and,

**WHEREAS**, while the range of investments permitted by A-4234 is still very conservative, it would save the taxpayers at least \$10 million per year; and,

**WHEREAS**, A-4234 would also reduce interest expense for local units of government and boards of education by creating an additional purchaser of their bonds; and,

**WHEREAS**, A-4234 would also permit JIFs to join together and create a joint investment and cash management program further increasing investment income; and,

**WHEREAS**, the Senate companion bill, S-2663 has already been adopted.

**NOW THEREFORE BE IT RESOLVED** by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey that:

1. The legislature is urged to adopt A-4234,

**WHEREAS**, Township of Wyckoff Ordinance #1328 was adopted on August 31, 1999 establishing the Township of Wyckoff Length of Service Award Program; and,

**WHEREAS**, on November 2, 1999, a referendum to establish a Length of Service Award Program was approved by the voters of the Township of Wyckoff; and,

**WHEREAS**, a Length of Service Award Program (LOSAP) was established to provide an inducement to obtain volunteers and to retain volunteers by establishing a tax-deferred income benefits to active volunteer members of the Township of Wyckoff's Volunteer Fire Department and Volunteer Ambulance Corp.; and,

**WHEREAS**, the 2016 year of active emergency service has been completed and all qualifying volunteer fire department and first aid participants has been calculated in accordance with NJSA 5:30 et seq.; and,

**WHEREAS**, the Chief of the Volunteer Fire Department and the Captain of the Volunteer Ambulance Corp have certified that the volunteers on the attached roster have satisfied the minimum requirements of participation established by the Township of Wyckoff LOSAP on a consistent and uniform basis; and,

**NOW, THEREFORE, BE IT RESOLVED**, that the Township Committee of the Township of Wyckoff approves the 2016 Qualifying Volunteer Fire Department and First Aid Squad roster as attached; and,

**WHEREAS**, PSEG representatives have met with representatives of the Township on March 2, 2017; and,

**WHEREAS**, PSEG has identified sections of three (3) roads in the Township which require existing gas main removals and replacement with gas system modernization materials; and,

**WHEREAS**, this work on sections of Woodland Avenue, Many Ann Lane and Vasser Street will require coordination with homeowners to modernize the gas connections to their homes; and,

**WHEREAS**, PSEG has requested relief from the existing working hours for utilities of 7:00am to 4:00pm to 7:00am to 6:00pm to accommodate property owners who may not be available during the day, however may be available at the end of the day and for permission to work on Saturdays for the same reason; and,

**WHEREAS**, PSEG has proposed to restore the areas of road they disturb with curb to curb paving on Woodland Avenue and Vasser Street and six inch base asphalt fill to grade in new pipe trenches on Mary Ann Lane with the understanding PSE&G would not be obligated to pave one (1) lane on Mary Ann Lane; and,

**WHEREAS**, PSEG has agreed to work with the Township Committee and perform and complete the gas main extension on Woodland Avenue before the start of the recreation summer camp program at the adjacent Memorial Field; and,

**WHEREAS**, this request has been reviewed by the Chief of Police, Township Engineer and Public Works Manager and they recommend the acceptance of this proposal; and,

**NOW THEREFOR BE IT RESOLVED**, by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey that the following is hereby authorized.

1. A road closure as designed and inspected by the Wyckoff Police Department for the duration of the gas main replacement and road restoration for the affected section of Woodland Avenue, Mary Ann Lane and Vasser Street is approved.

2. PSEG may work Monday thru Saturday and start at 7:00am to 6:00pm to perform and complete this work to accommodate the adjacent homeowners and for safe road restoration at the end of each work day.

3. The PSEG proposal to ; 1) pave the affected section of Woodland Avenue and Vasser Street curb to curb after a period of trench settlement is approved 2) restore all new gas trenches with six inch base asphalt to grade on Mary Ann Lane and PSEG would have no further responsibility for this section of Mary Ann Lane impacted by this gas main replacement project.

4. PSEG shall comply and perform all work in accordance with the Township of Wyckoff code sections 165-21 A, B, C, D, F, I J, K L, M, N and O.

**BE IT FURTHER RESOLVED**, that the Municipal Clerk shall provide a certified copy of this resolution to PSEG Project Manager, Police Chief, Public Works Manager and Township Engineer.
