Mayor Rudolf E. Boonstra opened the Open Work Session Meeting at 7:30 p.m. in the second floor municipal court room.

Mayor Boonstra announced that the Township Committee was pleased and honored to have the Washington School Student Council Leaders in attendance this evening.

Municipal Clerk Santimauro read the Open Public Work Session statement: "This Open Public Work Session Meeting of the Wyckoff Township Committee is now in session. In accordance with the Open Public Meetings Act, notice of this meeting appears on our Annual Schedule of meetings. A copy of said Annual Schedule has been posted on the Bulletin Board in Memorial Town Hall; a copy has been filed with the Municipal Clerk, The Record, The Ridgewood News and the North Jersey Herald and News – all newspapers having general circulation throughout the Township of Wyckoff. At least 48 hours prior to this meeting the Agenda thereof was similarly posted, filed and mailed to said newspapers."

Mayor Boonstra opened the meeting for the ten (10) minute total public comment period for any item on or off the Agenda, two (2) minutes per speaker, with a motion from Committeeman Madigan, seconded by Committeeman Carolan.

1. Ann Rizzo, 245 Demarest Avenue explained that she resides across from 240 Demarest Avenue, an abandoned and unoccupied building. Ms. Rizzo described the building as a nuisance, consistently attracting young people and teenagers who frequently break into the structure. The house is thought to be in foreclosure and the padlocks continue to be broken by vandals. Ms. Rizzo stated that her neighbor, a Village of Ridgewood police officer, observed juveniles running from the house after the locks were broken. At present, the house is uninhabitable and the maintenance performed on the property is not adequate. In 1999, the owners purchased this home for \$280,000 and did not realize that most of the surrounding property was designated as wetlands hence, the abandonment of the property.

Mayor Boonstra stated that he understands Ms. Rizzo's concerns and will review her issues and comments with Township Staff to reach a solution in this regard.

Committeeman Carolan motioned to close the public comment period, seconded by Committeeman Shanley with an affirmative voice vote.

Mayor Boonstra advised that the Finance Committee has reviewed and signed vouchers.
